DEED OF DEDICATION

KNOW ALL MEN BY THESE PRESENTS that LEROY A. KLATT, hereby dedicates to the City of The Dalles, for the public use, for a public street, the following described real property:

Beginning at a point on the northerly right-of-way line of Dry Hollow Road as presently used and travelled, said point being opposite and northerly 40 feet at right angles from the Engineer's Centerline Station 42+55.7, and located South 167.8 feet and West 1,170.17 feet from the Northwest corner of the Masonic Cemetery in the Northeast 1/4 of Section 10, Township 1 North, Range 13 East, Willamette Meridian, in Wasco County, Oregon; thence North 00°06'00" West along the West line of that property described in Wasco County Microfilm No. 891109 a distance of 23.13 feet; thence South 41°27'03" East 30.27 feet to the intersection with the northerly right-of-way of said Dry Hollow Road; thence South 88°43'32" West along the said right-of-way 20.00 feet to the point of beginning.

Contains 231.3 square feet, more or less.

SUBJECT TO all easements of record.

The City of The Dalles shall have the right to open, construct, improve, and maintain roads and streets of its design upon such lands and, in addition thereto, shall have the right to place or to permit others to place sidewalks, sewers, utilities, cables, pipes, electrical transmission wires, communications equipment, and such other improvements as the City shall deem necessary and convenient upon, above, or below the surface of the dedicated area.
