WHEREAS, the City has received a request to initiate street vacation for an alley segment between Riverview Street and I Street running 165 feet westerly from Riverview Street and Terminating at the westerly property line of tax lot 9100.

WHEREAS, Street Vacation 25-96 respectively, have been described to the City Council after being reviewed by the City Utilities, Mid-Columbia Fire and Rescue, Police and Planning Departments and the Northern Wasco County PUD; and

WHEREAS, there have been no objections by these departments; and


WHEREAS, street vacations are governed by ORS 271.080 through 271.230; and

WHEREAS, under ORS 271.130 the City Council may initiate the vacation process by providing notice (ORS 271.110) of public hearing and posting of notice no less than 14 days prior to the hearing; and

WHEREAS, it is in the best interest of the public for the City to initiate street vacations; and

WHEREAS, in addition to the statutory requirements, notice of the hearings should be sent to appropriate property owners that might be directly impacted by the proposal;

Section 1. Street Vacation Initiated. Street Vacation 25-96 an alley segment between Riverview Street and I Street running 165 feet westerly from Riverview Street and terminating at the westerly property line of tax lot 9100, section 3DC, Township 1N, Range 13E, WM, as shown on exhibit 1 attached.

2. Officers to Act. The City Planning Department is directed to post and publish notice for the street vacation initiated in Section 1, according to the provisions of ORS 271.110/
