DEED OF DEDICATION

KNOW ALL MEN BY THESE PRESENTS that ELMER KILE hereby dedicates to the City of The Dalles, for the public use, for a public street, the following described real property:

A tract of land in Hansen's 1st Addition, in the Southwest ¼ of the Southeast ¼ of Section 29, Township 2 North, Range 13 East, Willamette Meridian, City of The Dalles, Wasco County, Oregon, being more particularly described as follows.

Beginning at a point which is located at the Southeast corner of Parcel 2 of Minor Partition Plat No. 141-97, which point is marked by a 5/8" iron rod; thence West a distance of 50 feet to a point marked by a 5/8" iron rod; thence North a distance of 50 feet; thence East a distance of 50 feet; thence South a distance of 50 feet to the point of beginning.

The property to be dedicated is a 50 foot wide by 50 foot deep square on Parcel 2 of Minor Partition Plat 141-97 shown on Deed # 975190 filed with the Wasco County Clerk which exactly lines up with and immediately abuts the currently existing southwestern edge of the Right-of-Way of Garden Court West.

Contains exactly 2,500 square feet. The property is shown on the map attached as Exhibit "A".

The City of The Dalles shall have the right to open, construct, improve, and maintain roads and streets of its design upon such lands and, in addition thereto, shall have the right to place or to permit others to place sidewalks, sewers, utilities, cables, pipes, electrical transmission wires, communications equipment, and such other improvements as the City shall deem necessary and convenient upon, above, or below the surface of the dedicated area.

The consideration for this transfer is \$0.00. The property is to be used for public street purposes only.
