

RESOLUTION NO. 98-043

INITIATING A STREET VACATION PROCEDURE FOR THE FULL WIDTH OF A PORTION OF THE RIGHT-OF-WAY OF WEST TERRACE DRIVE, SUNRISE ADDITION, WHERE WEST TERRACE DRIVE IS BOUNDED ON THE NORTH BY TAX LOT 9600, MAP 1N-13-3CC, AND ON THE SOUTH BY THE SCENIC DRIVE RIGHT-OF-WAY

WHEREAS, the City has received a request to initiate a street vacation for the full width of a portion of West Terrace Drive between Tax Lot 9600, Map 1N-13-3CC to the north and the Scenic Drive right-of-way to the south (see attached map); and

WHEREAS, Street Vacation VAC 34-98 has been described to the Council after being reviewed by the City Public Works, Planning, and Police Departments, the Northern Wasco County PUD, and Mid-Columbia Fire and Rescue; and

WHEREAS, there have been no objections by these departments and agencies; and

WHEREAS, street vacations are governed by ORS 271.080 through 271.230; and

WHEREAS, under ORS 271.130, the City Council may initiate the vacation process by providing notice (ORS 271.110) of public hearing and posting of notice no less than 14 days prior to the hearing; and

WHEREAS, it is in the best interest of the public for the City to initiate a public hearing for the requested street vacation; and

WHEREAS, in addition to the statutory requirements, notice of the hearing should be sent to appropriate property owners that might be directly impacted by the proposed street vacation;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL AS FOLLOWS:

Section 1. Street Vacation Initiated. Street Vacation No. 34-98, which is further described on the map attached as Exhibit "1", is hereby initiated.

Section 2. Officers to Act. The City Planning Department is directed to post and publish notice for the street vacation initiated in Section 1, according to the provisions of ORS 271.110.


