

RESOLUTION NO. 98-047

INITIATING STREET VACATION PROCEDURES FOR:  
REQUEST BY RON CARPENTER TO AMEND PREVIOUS STREET  
VACATION REQUEST AND TO REQUEST TO VACATE A PORTION OF  
WEST 17<sup>TH</sup> STREET BETWEEN GARRISON STREET AND WEST 17<sup>TH</sup>  
STREET'S INTERSECTION WITH SCENIC DRIVE, ADJACENT TO  
PROPERTIES LOCATED IN THE NORTHWEST  $\frac{1}{4}$  OF THE SOUTHEAST  $\frac{1}{4}$ ,  
SECTION 4DC, TOWNSHIP 1 NORTH, RANGE 13 EAST, INCLUDING TAX  
LOTS 13400, 13500, 13600, 13700, 13800; AND, TO ADDITIONALLY  
INCLUDE THE SOUTHWEST  $\frac{1}{4}$  OF THE SOUTHEAST  $\frac{1}{4}$  OF THE SAME  
TOWNSHIP AND RANGE TO INCLUDE TAX LOT 1100

WHEREAS, the City Council previously adopted Resolution No. 98-022, which initiated  
a request for a larger street vacation, which included the area of this particular street vacation  
request; and

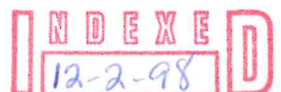
WHEREAS, the City has received this request to amend the previously initiated request  
such that the street vacation is for sections of right-of-way to properties located in the Northwest  
 $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$ , Section 4DC, Township 1 North, Range 13 East, including Tax Lots  
13400, 13500, 13600, 13700, 13800; and, to additionally include the Southwest  $\frac{1}{4}$  of the  
Southeast  $\frac{1}{4}$  of the same township and range to include Tax Lot 1100; and

WHEREAS, the Amended Street Vacation 29-97 has been described to the City Council  
after being reviewed by the City Public Works Department, Mid-Columbia Fire and Rescue,  
Northwest Natural Gas, Northern Wasco County PUD, Police, and Planning Departments; and

WHEREAS, there have been no objections by these departments; and

WHEREAS, street vacations are governed by ORS 271.080 through 271.230; and

WHEREAS, under ORS 271.130, the City Council may initiate the vacation process by  
providing notice of public hearing and posting of notice no less than 14 days prior to the hearing;  
and



WHEREAS, it is in the best interest of the public for the City to initiate certain street vacations; and

WHEREAS, in addition to the statutory requirements, notice of the hearing should be sent to appropriate property owners that might directly be impacted by the proposals;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL AS FOLLOWS:

Section 1. Amended Street Vacation Initiated. Amended Street Vacation 29-97, for the sections of the rights-of-way adjacent to properties located in the Northwest  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$ , Section 4DC, Township 1 North, Range 13 East, Including Tax Lots 13400, 13500, 13600, 13700, 13800; and, to additionally include the Southwest  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of the same township and range to include Tax Lot 1100, as shown on Exhibit 1 attached, is hereby initiated.

Section 2. Officers to Act. The City Planning Department is directed to post and publish notice for the street vacation initiated in Section 1, according to the provisions of ORS 271.110.
