MARCH 21, 2022

CALL TO ORDER

President Tiffany Prince called the meeting to order at 4:00 pm.

ROLL CALL

City Clerk Izetta Grossman conducted roll call;

APPROVAL OF AGENDA

It was noted that Grossman sent an email adding Action Item #7B Wind Sculptures.

It was moved by Ferrer and seconded by Lennox to approve the agenda as amended. The motion carried 4 to 0; Krummrich and Rahmlow absent; Ferrer, Lennox, Prince, Nelson voting in favor; none opposed.

APPROVAL OF MINUTES

It was moved by Lennox and seconded by Nelson to approve the minutes of the January 3, 2022 Regular Beautification Committee Meeting as presented. The motion carried 4 to 0; Krummrich and Rahmlow absent; Ferrer, Lennox, Prince, Nelson voting in favor; none opposed.

Krummrich arrived 4:04 p.m.

Welcome Sign Update

David Mills – Transportation Division Public Works

Mills asked if the Committee liked the medallion that is used on the sign at Public Works on the west side.

The east side of town would have a metal sign with the same medallion. The west side sign is behind the existing ODOT sign. He said the sign height is a minimum of 7 feet.

It was the consensus of the Committee to use those designs, since it matches the City vehicles and new website.

Stop the Drop/Community Clean-ups

Krummrich said things were going well. She thanked Prince for finalizing Columbia Gorge Community College as the guest host in May.

Ball Caps

Krummrich said 20 caps had been ordered. She said she would take some to the clean ups and offer them for sale.

Grossman said she had received an email that the caps were ready. She said she would pick them up on Tuesday.

Beautification Award

Krummrich and Nelson said they have narrowed the search, one home owner asked to wait, as they are doing some work.

Krummrich said she would check in with Rahmlow to get Grossman the address and name for the water bill.

ACTION ITEMS

Finalize Council and Budget Committee Presentation

Grossman said that the City Manager asked that the irrigation be added back into the 1st Street Design.

Krummrich asked about benches on 1st Street. Grossman said the Committee needed to attend an Urban Renewal Meeting to have a conversation with them.

Lennox said he felt it was important to identify the priorities and then have the Mayor become an advocate.

He said he would like to see a comprehensive tree plan within the City. He suggested a tree development program, with a paid consultant to head up the program. He said it was time to change the culture in the City.

Ferrer agreed that the City should hire someone to work on an overall plan, coordinate the planting and maintenance of trees and plantings. She said maybe a RARE Planner.

Nelson said connect at the State and Federal level to watch for funding opportunities.

Krummrich said she sees The Dalles as a diamond that needs to be polished. She said the Committee needs to be a cheerleader.

She said we need more employees to accomplish these things.

Nelson said pedestrian movement should be coordinated with tree plantings, art, sculpture for in the future.

Krummrich suggested taking the three things identified at an earlier meeting.

Wind Sculpture Project

Committee suggesting more wind sculpture located at various locations (see report)

Ferrer reviewed the three locations with photos.(see attached)

1. One sculpture at the island by Monteria's – Indian Paint Brush 36" x 15"
2. Trevitt Triangle – Ponderosa - 6ft tall x 3 ft wide (alternate spot – memorial at Sorosis; by bench at Dock)
3. Planter at the Plaza at the Dock – Earth, Fire, Water

Lennox suggested starting the Presentation with the Wind Sculptures and move into the trees.

It was moved by Prince and seconded by Nelson to approve the purchase of the wind sculptures presented. The motion carried 5 to 0; Prince, Nelson, Lennox, Ferrer, Krummrich voting in favor; Rahmlow absent.

Krummrich thanked everyone for the teamwork. She said she's so pleased to see the positive movement.
