Shorenstein: (5600 Meadows): There is site grading in progress and the foundation work is proceeding Slowly. The utility work has not been scheduled yet.

16667/16607 Boones Ferry (Sunset Crossing): The plans and designs resumes, and they are now requesting new meters, both fire and domestic.

15570 Waluga Partition – A preconstruction meeting was held on May 11, 2022, and two new services are being requested and the existing service will be abandoned.

Updated the inventory of properties served outside the District or served by the City of Lake Oswego that are in the District.

Future land developments that are still pending:

- a. Summer Woods/Washington Ct. A 3-lot partition was submitted for approval and will require an extension of the District main line.
- b. There is a potential five lot development on Baleine and Inverurie.
