#### **RECOMMENDATION:**

Consider a motion to direct the City Recorder whether to close or extend the recruitment period for the City Council District No. 1 vacant position for a term expiring December 31, 2020.

#### **EXECUTIVE SUMMARY:**

Councilor Hayley Delle represented District 1 on the Newberg City Council from January 3 - May 16 of 2017. She resigned due to family obligations. The Council declared a vacancy for the position on May 16, 2017 through Resolution 2017-3380.

During May-June 2017, the position was advertised and applications were accepted for the position. Two applications were received. One applicants did not meet the requirements and the remaining candidate, Marc Shelton, withdrew his application from consideration due to responsibilities with his employer.

Additional recruitment was done via website, legal notice in the Newberg Graphic, posters and direct letters to qualified committee members who reside within the boundaries of District 1.

As of July 27, 2017 two applications for viable candidates have been received by the City Recorder. The candidates are Helen Brown and Matthew Murray. Additional direction is needed from the City Council on whether to close the recruitment and schedule a date for interviews or to extend the recruitment and do additional outreach.

#### **FISCAL IMPACT:**

If the recruitment is extended, the City Recorder proposes to do direct mail campaign to the registered voters within District 1. This would incur a small amount (less than \$1,000) in printing and mailing. For Newberg Council District 1 there are currently 1,405 on file with Yamhill County Elections.

## STRATEGIC ASSESSMENT:

The council sets policy and direction for the City. It is critical for the city council to have a full complement of its membership in order to carry on the business of the City. The selecting the most qualified candidate to fulfill the District No. 1 vacant position is important to ensure the citizens within its boundaries are fairly represented.

### **EXECUTIVE SUMMARY:**

**Matters to the Ballot** 

Due to the late hour of the July 17, 2017 council meeting, the council did not have an opportunity to discuss the imminent election deadlines that will limit the opportunity to refer matters for the November 7, 2017 election. Due to the imminent deadline, a special council meeting was called.

As required by state law, submission of a ballot title and explanatory statement must be completed and filed with the election official not later than August 18, 2017 (80 days prior to the election) to appear on the November 2017 election. In order to meet the Newberg Graphic's publication deadlines, the practical deadline is at least a day prior.

The council must approve the ballot title and explanatory statement prior to filing the same with the election official. The August 7 council meeting is the final opportunity for the council to approve a ballot title and explanatory statement. Therefore, this meeting is the last opportunity for the council to take any action and still be able to meet the election deadlines.

The ballot title and explanatory statement for the annexation election are near a final draft and will be ready for presentation and approval at the August 7 meeting.

FISCAL IMPACT: Unknown.
