

**CITY OF ASTORIA
RESOLUTION RES 22-19**

**A RESOLUTION OF THE CITY OF ASTORIA RELATING TO FEES FOR CITY
SERVICES: SCHEDULE F1 AND F2**

WHEREAS, the various departments of the City incur expenses in searching for and furnishing copies of records, reports and documents, and providing special services for private individuals and private concerns. The City Council deems it advisable, for the efficient conduct of the affairs of the various departments, that reasonable fees be charged for furnishing such records, reports, documents and services. A deposit may be requested in advance of providing the requested information.

WHEREAS, the fee schedules for the various Departments of the City of Astoria are attached to this Resolution and identified as follows: Building Inspection, A1 – A7; City Administration, B1 – B2; Community Development Department, C1 – C3; Fire Department, D1; Library, E1; Parks and Recreation Department: Aquatic Center Fees, F1, Maritime Memorial Fees, F2, Ocean View Cemetery Fees F3, Recreation Division Rental Fees, F4, Astoria Column, F5; Police Department, G1; Public Works/Engineering Department, H1 – H2

WHEREAS, the fees shall be charged whether the request for the service is made in person, by telephone or in writing.

WHEREAS, no law enforcement agency, Civil Service Commission or department of the Armed Forces is required to pay the fees established in Section 1 of this resolution.

WHEREAS, fees collected under the provisions of this resolution shall be remitted to the Finance Department. The Finance Director shall deposit the fees received in the appropriate established fund.

NOW THEREFORE, be it resolved by the City Council of the City of Astoria:

SECTION 3: **REPEALER CLAUSE** Resolution No. 20-17 adopted June 21, 2021, is repealed.


SECTION 4: **EFFECTIVE DATE** The provisions of this resolution shall be effective July 1, 2022.


