Ray Young gave a brief overview of the staff report.

Mayor Lauer opened public hearing at 7:28pm.

Rich Allen, Troutdale resident, stated it looks good.

Mayor Lauer closed the public hearing at 7:28pm.

Councilor White stated when there was work being done on the Troutdale Bridge, the subcontractors that ODOT hired were very conscious of trying keep within the mandated hours and not disrupt the public. He stated he's okay with Ray Young making the call.

Councilor Kranz stated everything looks good and makes sense to eliminate work when needed to increase efficiency.

Councilor Glantz stated she's behind the general concept and would like to get it out of MCSO's roles/responsibilities. She stated under Item D where it states, 7 days and 7 days towards the 14-day total, it states calendar days. She asked what would happen if someone turned it on a Friday and the next Friday is a holiday.

Ed Trompke stated calendar days means calendar days.

Councilor Ripma stated the wording is no more than 14 calendars days so he thinks the wording is okay.

Councilor Kranz asked if it would be possible to edit or revise the ordinance to show business days instead of calendars days.

Ray Young replied now is a good time to let staff know of any changes.

Ed Trompke stated if there is a consensus of Council, it's appropriate to ask to make changes to bring for the next hearing.

Councilor Ripma stated if the language is changed from calendar days to business days it lengthens the time. He doesn't think the time should be lengthened.

Mayor Lauer agreed with Councilor Ripma.

Councilor Moon stated he prefers the existing language of calendar days.

Councilor Glantz stated shortening it to 5 business days sounds better and is more descriptive.

Councilor Kranz stated the language as is is adequate.

Councilor Kranz stated she made a comment at the previous council meeting in 2020 saying she completely loved what the URA could be from presentation. She stated she wants to retract her statement because she is not nuts about seeing 13 apartment units down in the URA. She doesn't think it is the best use for the area. She chides with Councilor White who made that statement. It's not her vision and she wanted to clarify. She explained that she is serving on a subcommittee, the EMCTC, and she was asked if she would be representing the City of Troutdale again moving forward.

Councilor White nominated Jamie Kranz to continue serving on the EMCTC.

Mayor Lauer agreed with Councilor White's nomination. He stated he's looking forward to working with the Council for the next 2 to 4 years.

Councilor White congratulated the Mayor and new Councilors. He stated there was an extension on the CARES Act.

Ray Young stated the use of the CARES money from last year has been extended. The City of Troutdale signed an amendment to the IGA with the City of Portland allowing to the end of January to spend the remainder of the money.

Councilor Moon welcomed the new Councilors.

Councilor Glantz stated she is looking forward to working with everyone. She asked if Council looks at things like what can be done to help businesses. She brings it up because she got feedback from a couple residents who were unhappy that it was suggested businesses be open and defy the State's order. She would like if the Council could brainstorm and find a way to help businesses during COVID.

Mayor Lauer stated it's appropriate to bring up and he thinks it's something the City Council should be working towards. He stated it's something that could be discussed at a later Council meeting or work session.

Councilor Glantz stated she would like to get public feedback also. She would like to possibly get a representative of Mt. Hood Legacy Hospital to come in and give feedback.

Councilor Ripma stated he thinks Troutdale has set a great example of American democracy. He asked for people to be safe and be kind.

Councilor Caswell stated she has been thinking about what Councilor Glantz mentioned with local businesses and Council helping in any way. She thinks now is an important time and not wait too long. She agrees with asking for community and business owner feedback and do what is best for the people. She mentioned that Mike Greenslade, a local developer, offered to host the City Council on a field trip to show examples of quality developments that are happening on the west side to show what's going on and what is working in higher end developments.

Ed Trompke stated if a quorum of the Council gets together, you must be careful not to discuss anything that could be considered deliberating on a subject that is likely to come before the Council such as any potential legislative or administrative action. It's difficult to get 4 or more Councilors together because the public meetings laws need to be followed and every step of the way must be ADA accessible, noticed a week in advance and other requirements that are problematic. If only 3 Councilors went, that would be okay.
