#### 1. PLEDGE OF ALLEGIANCE, ROLL CALL, AGENDA UPDATE

Mayor Lauer called the meeting to order at 7:00pm.

- **PRESENT:** Mayor Lauer, Councilor Ripma, Councilor Caswell, Councilor White, Councilor Moon and Councilor Glantz.

- **2. PUBLIC COMMENT:** Public comment on non-agenda and consent agenda items is welcome at this time.

Paul Wilcox, Troutdale resident, stated he has a comment regarding consent agenda item 3.2. He pointed out that no one was appointed to the Historic Landmarks Commission alternate. He saw Norm Thomas applied and wonders why Norm's term wasn't extended. At the June 2<sup>nd</sup> Citizens Advisory Committee (CAC) meeting, Tim Erich announced he's moving out of state. He's on the CAC and also on the Budget Committee which will leave no alternates for the next year. The Public Safety and Equity Advisory Committee (PSEAC) appointments had 3 applicants and the rest applied to other committees that hadn't actually applied to the PSEAC. He's not sure that was a good idea. It was just kind of grabbing people out of the room. The City doesn't have the diversity intended for that group. Resolutions 3.3 and 3.4 on the consent agenda seem to have significant changes. He would have preferred to not have them on the consent agenda.

Chris Damgen, Community Development Director, gave a brief overview of the staff report.

Paul Wilcox stated the definition of overnight parking says anytime between 2am and 6am. If someone is occupying a space at 2:15am or arriving at a space at 5:45am, he wouldn't consider that overnight parking. The signage should specify no parking from 2-6am.

Ray Young, City Manager, stated there are no overnight parking signs now but he can have hours added and can make the call to get new signs with the designated times.

Chris Damgen gave a brief overview of the staff report and explained that the State said the Housing Needs Analysis (HNA) should have been approved via ordinance and not as a resolution. The ordinance is to amend Goal 10 and removes antiquated language and reference the already adopted HNA and acknowledges that ADUs are allowed. There are no changes from last year.

Chris Damgen stated he will try to get that up to date and fixed for the next reading.

#### Mayor Lauer opened the public hearing at 7:23pm.

Rip Caswell, Troutdale resident, stated he's wondering why there isn't information in the analysis about the need for high-end housing. It seems to focus only on low-end housing.

Chris Damgen replied typically HNAs show the number of needs based on different income brackets. There is low and high-end housing. The document largely focuses on a standard snapshot. High income is based on market demand, building, promoter, etc. In more recent docs (Town Center Plan) that issue is highlighted and he expects other planning documents to highlight that, especially for the Confluence site and along the river.

Councilor Glantz stated she thought there were a few things put in the document regarding executive housing, but she couldn't find it.

Chris Damgen replied he would have to check the record on it. He thought it was decided not to focus on one because there is a need on both ends of the spectrum. Fundamentally nothing has changed.

Councilor Moon stated the data shows it on some of the graphs. It's pretty obvious that there was a deficit in upper income housing.

Councilor White stated it's on page 88.

Tanney Staffenson, Troutdale resident, stated he served on the committee that created the HNA. He explained, in the \$100,000 plus income range there is a deficit of 1,054 units and in the \$350,000 and below income range there is a deficit of 611 units.

Councilor Caswell stated she liked what Tanney said about mentioning the 2 both equally. On page 96, there is a bullet point that says unmet need for low-income housing. It might be a good idea to add a bullet point for the need for high-income housing.

was a \$1.9 million deficit, and this recovery fund was included in that. The great thing about getting money is you get it, and the bad thing is you only get to spend it once. This money was already kind of earmarked, it just wasn't line itemed.
