5. PUBLIC HEARING / ORDINANCE (Introduced 6/14/22): An ordinance amending Chapters 1, 3, 5 and 8 of the Troutdale Development Code and declaring an emergency (HB 2001 / Middle Housing).

Chris Damgen, Community Development Director, gave a brief overview of the staff report and showed the Council a slideshow (attached as Exhibit A).

Councilor White asked if you have a single-family lot that can now have 4 units on it, is there a danger of that lot being reassessed for tax purposes.

Chris Damgen replied yes.

Ed Trompke stated the County has an obligation to reassess whenever a development application is approved. It would reassess for the 4 units.

Mayor Lauer opened the public hearing at 7:15pm.

Paul Wilcox read a self-prepared statement (attached as Exhibit B).

Tanney Staffenson, Planning Commission Chair, stated that the Planning Commission voted to move this along. They support the change going from 32 down to 20 and appreciates Council taking the extra meeting to make it an emergency to get the City under the wire and in compliance. He stated there will be Senate Bill 458 that will be coming the City's way. The Planning Commission has already started tackling it. They are going to ask the representatives to come in and help with understanding what they're thinking with some of the language in the bill.

Councilor Ripma stated he doesn't disagree with Paul Wilcox or Chris that single-family homes still can be built. What is lost is the availability of single-family only developments. He's worried about it. Single-family only developments are a standard in the Country. They don't have to be expensive or exclusive or anything else. They are what Americans have liked for a long time. The risk of this kind of infill is that it erodes the single-family development. He doesn't like the ordinance but he's voting for it because he recognizes that it needs to be passed.

MOTION: Councilor Ripma moved to adopt an ordinance amending Chapters 1, 3, 5 and 8 of the Troutdale Development Code and declaring an emergency (HB 2001 / Middle Housing). Seconded by Councilor White.

Mayor and Councilors,

I'd like to address a comment made by Councilor Ripma at the last Council meeting on June 14th. I've transcribed his comment off the recording so as to quote him accurately. "I also think that this requirement that cities basically eliminate single family detached housing as an option for cities in some areas, I mean you can't be restrictive in cities, but removing that as an option, what I consider as the American dream of having a single family house, eliminating that as an option makes us all less free. It was really bad." – Councilor Ripma

In the findings of fact for criterion E you'll find the following statement, which has been reiterated repeatedly by Community Development Director Chris Damgen. "Furthermore, nothing in the amendment – nor in state law – eliminates the possibility of building (or re-building) single-family detached structures."

If you look at recent construction activity in R-4 residential housing zones, which allow for both attached and detached dwellings, there are examples of both. It's a decision by the individual developer which housing typology will be built.
