

#### For projects in the following metropolitan counties:

Clackamas	Marion	Washington
Columbia	Multnomah	Yamhill

- (A) All jobs or projects located in Multnomah, Clackamas and Marion counties, West of the western boundary of Mt. Hood National Forest and West of Mile Post 30 on Interstate 84 and West of Mile Post 30 on State Hwy 26 and West of Mile Post 30 on Hwy 22 and all jobs located in Yamhill County, Washington County and Columbia County shall receive Zone 1 pay for all classifications.
- (B) All jobs or projects located in the area outside the *identified boundary* above, but less than 50 miles from the Portland City Hall shall receive Zone 2 pay for all classifications.
- (C) All jobs or projects located more than 50 miles from the Portland City Hall, but outside the identified border above, shall receive Zone 3 pay for all classifications.

#### Reference cities for projects in all remaining counties:

Albany	Coos Bay	Grants Pass	Medford
Bend	Eugene	Klamath Falls	Roseburg

- (A) All jobs or projects located within 30 miles of the respective city hall of the above mentioned cities shall receive Zone 1 pay for all classifications.
- (B) All jobs or projects located more than 30 miles and less than 50 miles from the respective city hall of the above mentioned cities shall receive Zone 2 for all classifications.
- (C) All jobs or projects located more than 50 miles from the respective city hall of the above mentioned cities shall receive Zone 3 pay for all classifications.

**Note:** All job or project locations shall be computed (determined) on the basis of road miles and in the following manner. A mileage measurement will start at the entrance to the respective city hall, facing the project (if possible), and shall proceed by the normal route (shortest time-best road) to the geographical center on the highway, railroad, and street construction projects (end of measurement). On all other project contracts, the geographical center where the major portion of the construction is located, shall be considered the center of the project (end measurement).

Add \$10.00/hour hyperbaric pay for Group 4 Tunnel Boring Machine Mechanic.

Add \$0.40 to the base rate for any and all work performed underground, including operating, servicing, and repairing of equipment.

Add \$0.50 to the base rate per hour for any employee who works suspended by a rope or cable.

Add \$0.50 to the base rate for employees who do "pioneer" work (break open a cut, build road, etc.) more than one hundred fifty (150) feet above grade elevation.

**Note:** A Hazardous Waste Removal Differential must be added to the base rate if work is performed inside the boundary of a Federally Designated Waste Site. For information on this differential, call the Prevailing Wage Rate Coordinator at (971) 353-2416.

Shift Differential

Two-Shift Operations:

On a two-shift operation, when the second shift starts after 4:30 p.m., second-shift workers shall be paid the base hourly wage rate plus 5% for all hours worked.

When the second shift starts at 8:00 p.m. or later, the second-shift workers shall be paid at the base hourly wage rate plus 10% for all hours worked.

Three-Shift Operations:

On a three-shift operation, the base hourly wage rate plus five percent (5%) shall be paid to all second-shift workers for all hours worked, and the base hourly wage rate plus ten percent (10%) shall be paid to all third shift workers for all hours worked.

## 00120.05 Request for Plans, Special Provisions, and Bid Booklets

(REPLACE) Delete the first paragraph and replace it with below:

Bidders shall obtain Solicitation Documents from the City's website at **http://www.ci.the-dalles.or.us/current\_job\_openings.htm**. Bidders will be responsible for checking the website regularly for addendums and additional information for the project.

### 00120.40 Preparation of Bids (e)

(REPLACE) Delete the second and third paragraph and replace it with below:

The Bid guaranty shall be a Surety bond using the Agency's standard Bid Bond form included with the Bid Booklet. The Bid guaranty shall be submitted with the bid booklet as described in 00120.45.

## 00120.45 Submittal of Bids

(REPLACE) Delete the paragraph and replace it with below:

Bids shall be submitted as instructed in the Advertisement for Bids and Invitation to Bidders.

## 00150.15 Construction Stakes, Lines, and Grades

(REPLACE) Replace the entire section with the following:

### 00150.15 Construction Stakes, Lines, and Grades:

(a) General - General layout of the project, including line and grade, will be furnished by the contractor. The contractor shall conduct all necessary surveys and field investigations to accuracy standards consistent with construction tolerances. Surveys shall be performed by a land surveyor licensed by the state of Oregon or a qualified engineer.

(b) Agency Responsibilities - The Agency shall conduct surveys as necessary to provide ties between control points or construction base lines established in the plans and existing monuments with descriptions available from Wasco County or City of The Dalles. If the stakes, monuments, or other reference points are destroyed or damaged by the contractor, it will be the responsibility of the contractor to replace same at no expense to the Agency.

(c) Contractor Responsibilities - The contractor shall establish all field controls necessary for construction of the project in accordance with the plans and specifications from the control points or construction base lines established by the Agency. In addition, the contractor shall obtain any permission required prior to entering upon private property to perform any task required. In the event contractor is denied access to private property, contractor shall immediately notify the Project Manager and give the location to which access was denied, the name of the person who denied access, the reason access was sought, and any alternative site that may be used for the same purpose. Agency shall thereupon endeavor to assist contractor in gaining the required access.
