
# DEQ Proposal for Cap and Reduce Rules Advisory Committee

## New GHG Reduction Program

- Establish overall greenhouse gas limit on:
  - Large stationary sources
  - Transportation fuels
  - All other fossil fuels including natural gas
- Program must be created using existing legal authority of the EQC

# Public Engagement

- 160 attendees at scoping kickoff meeting in July
- Over 100 attendees at each of six technical workshops to discuss specific program design elements
- Over 100 attendees at each of three town halls
- Nearly 650 written public comments submitted






# Public input identified the following program goals:

Prioritize **equity** by promoting benefits and alleviating burdens for environmental justice and impacted communities

Reduce GHG <u>emissions</u> by including a broad scope and ambitious decline

Contain <u>costs</u> for businesses and consumers

## Rule Advisory Committee Selection Process

- DEQ held an open application to participate on the Rule Advisory Committee (RAC)
- Key principles and considerations for selecting RAC:
  - Large enough to reflect most perspectives, but small enough that all members can speak
  - Full range of opinions, with no one perspective dominating
  - Account for different capacity and resources from different members to allow for equitable participation
  - Prioritize Oregon-based companies and organizations
  - Recognize prior participation in program scoping or unique expertize



#### Role of the RAC

- Work of the RAC will include:
  - Making recommendations on program and policy options
  - Reviewing, evaluating and suggesting draft rule language
  - Evaluating the fiscal, environmental and public health implications of draft rules
- DEQ will not seek consensus from the RAC
  - Program will be complex, with broad scope
  - Committee discussions will inform development of draft rules to propose for public review and comment
- DEQ will seek public engagement and input at RAC meetings, not just from RAC members




