Rahmlow called the meeting to order at 4:01 pm.

APPROVAL OF MINUTES

AUDIENCE PARTICIPATION/PRESENTATION

Rachel Carter from Columbia Gorge Toyota and Honda talked about how they are starting up the 2^{nd} Saturday Cleanups and how she would like to see representation from the Beautification Committee now that Krummrich is stepping down. The committee explained that there would be a signOup sheet so everyone takes turns and it does not fall on just one person.

Ferrer volunteered to take on the coordination and duties Krummrich outlined. However, she cannot commit to being there every Saturday.

COMMITTEE REPORTS

Stop The Drop/All Together The Dalles Monthly Cleanup

Krummrich reported that on April 3rd at 7:55am there will be an assembly at Dry Hallow Elementary School where students will learn about Stop the Drop. On March 27 & 28 Krummrich with be attending the music classes at Colonel Wright Elementary School and will be teaching them the song.

DISCUSSION ITEMS

Ferrer and Rahmlow to send final copy before deadline.

Sanchez mentioned that starting the beautification committee would be getting a full page in the newsletter and that moving forward they would have a column depending on the space available.

Community Outreach-Grant Application

Ferrer shared the updated application in its draft form. See draft attached to the minutes. She also mentioned that the trees would be bigger. Ferrer will pick up trees once a source is picked out.

Kavanagh mentioned that trees are \$150 for a tree about six feet tall, the bags are around \$20, and the pipes are something that could be done in-house for a cheaper rate.

Master Gardeners will develop handout with instructions to handout with the trees.

April 29th was chosen as Giveaway Day as to not to conflict with Cherry Festival.

Sanchez mentioned that it would need to go through legal to make sure everything is okay to go before pushing out the application.

Pressure Washing

Krummrich gave some history on previous project. It cost \$20,000 to pressure wash the sidewalks in downtown. The City's Public Works did not want to buy the equipment and did not have the work force to do the cleaning.

The committee would gladly support such efforts.

Kelly Triangle

The college presented their Four Seasons Cheery Tree. It would be made of aluminum and steel. It would be 5ft tall and 5ft wide. The cost is around \$800-\$1,000 that is the fabrication and installation of the structure. We have to take into account that it does not black the line of sight of 12th Street.

The whole committee loved the drawing. Sanchez asked if there were more drawings to choose

from or that could be made into smaller sculptures to place on Kelly Triangle.

The college will present other drawings as soon as they have them.



City of The Dalles Beautification Committee 2023 Arbor Day Tree Grant Application



City of The Dalles Beautification Committee Mission:

To add to the rich cultural history of our place; share the beauty of our community; and instill a sense of pride in our public, private, and communal outdoor spaces.

Program Purpose:

The purpose of the program is to provide grants for residents of the City of The Dalles to beautify and otherwise improve their property with trees.

The Beautification Committee recognizes the many benefits that a healthy urban forest provides. Trees certainly make our neighborhoods more beautiful, but they also increase property value of our homes, and enhance economic vitality in business districts. On hot summer days, trees provide essential shade, cooling our yards and buildings, and saving energy. Trees improve soil, air, and water quality, and can also improve our quality of life: they boost our mental and physical health and provide homes to wildlife we value.

Grant Process

City of The Dalles Beautification tree grants are available to residents within the city limits of The Dalles.

Applicants must complete either the online application form at

<u>https://forms.gle/bCWtcwqJQgDtWVeY6</u> or the attached application form to be returned to the City of the Dalles as directed on the form. Applicants will select their preferred tree species from an approved list as part of the application process. The trees will be approximately 1.25 - 1.5 inches in diameter and 5' - 6' tall.

If irrigation is not available where the tree will be planted, applicants may also request a **tree gator** (right), a watering bag to help water the tree regularly, and/or a **perforated pvc tube** (far right) to place in ground next to your tree to help water your tree more deeply. See application form.



Completed applications must be submitted by April 3, 2023. If approved applications exceed the available funds for this project, grant awards will be determined on a first-come first-serve basis by the date/time the application was submitted. Returning your application as soon as possible will also make it more likely you'll get your first choice of tree variety.

Completed applications will be reviewed by the Beautification Committee and may be approved, rejected (due to existing site constraints), or additional information from the applicant may be requested.

Approved Tree Grant recipients will be notified by April 10, 2023. Tree Grant recipients may pick up their trees on Saturday April 29 at Thompson Park (602 W 2nd St) from 10:00 am to 1:00 pm. Wasco County Master Gardeners will be on hand to provide information about planting and caring for your tree.

Grant Requirements and Information

All properties and planting sites must be within the city limits of The Dalles.

Applicants must be the property owner.

Grants are limited to one tree per property owner per year.

Trees are to be planted in the public right-of-way (parking strip). If your street does not have a public right of way where the tree may be planted, your tree may be planted in the front yard as long as it is clearly visible from the street.

An underground utility request must be submitted by you at least 48 hours prior to planting the tree. Call the Oregon Utility Notification Center at 1-800-332-2344 or by dialing 8-1-1.

Tree Options

All applicants should review the descriptions of these available trees to select the species that best suits the area where the tree will be planted. Your proposed planting area should be sufficient in size to accommodate the mature tree. Take note of what trees are currently in your neighborhood and consider planting other species. If you have a narrow planting area adjacent to a public sidewalk, a tree with a narrow canopy may be ideal to accommodate sidewalk clearance.

European hornbeam October Glory maple Autumn Blaze maple Thornless Hawthorne Maybe a smaller maple, too, maximum 25 -30 ft

We are still finalizing this list of 4-5 tree species/varieties that are recommended by our local extension office AND are available from a nursery in the area. A list of varieties will go here and we'll also have a page with details on each – photos, growth habits, etc.
