#### 5. DEPARTMENTS:

**COMMISSIONERS:** Larry Kitchen states that the Board needs to set some time (workshop) to start making serious decisions regarding the new water contract.

**OFFICE:** District Manager reported that the office landlord (Shorenstein) will not extend a new three-year office lease but is willing to extend the lease for another six months.

**FIELD OPERATOR:** Silas Olson announced that Hiland Water has been acquired by NW Natural. Business will be as usual for the District. J.J. Olson discussed the lead and copper rule to include inventory and process throughout the District in the next fifteen months to meet the October 2024 deadline. Progress reports will be submitted monthly to the District Manager. Phase III of the hydrant replacements will start after July 1, 2023.

**ENGINEER:** Current updates on the following projects:

Shorenstein: (5600 Meadows): As built documentation remains the same.

Fire hydrant replacement at Waluga and Firwood is pending. Total cost by Lake Oswego is on hold until Lake Oswego provides authorization to proceed.

Leaks

- A. Leak was detected on the service line at Bryant near Upper Dr. is under evaluation and the survey was received.
- B. Boones Ferry break and repair draft plan is completed and accepted by the City and is currently working with Hiland on a traffic plan.

16607 & 16667 Boones Ferry have been approved by DRC construction. Construction schedule is still unknown.

Preliminary plans for the abandonment of the 12-inch line on Carman – a redesign is in progress.

## Future land developments that are still pending:

- a. Summer Woods/Washington Ct. A 3-lot partition has been approved and posted.
- b. There is a three-lot on Babson plans have been approved by the city with two new services.
- c. There is a potential development on Seville and Astor.
- d. Baliene/Kimball Ct. A service provider letter is work has been sent.
