ACTION REQUESTED: Adoption

<u>PURPOSE</u>: To approve the tentative 2022-2026 Collective Bargaining Agreement that is scheduled to be ratified by ATU membership on Thursday, February 9, 2023.

<u>DESCRIPTION</u>: Lane Transit District (LTD) and the Amalgamated Transit Union (ATU) Local 757 have reached a tentative four-year collective bargaining agreement that increases wages, clarifies work schedules, and adds holidays for the union's non-supervisory and non-administrative members of Operations, Fleet, Materials Management, and Customer Service departments.

Highlights of the tentative agreement include:

- 22% pay increase over the next four years
- \$450 bonus for each operator who performs EmX work between November 1 and October 31
- Add Juneteenth and Martin Luther King, Jr. days as observed holidays
- Clarification concerning work assignments and schedules based on workforce levels and service requirements
- Improves work-life balance by ensuring every employee receives their regularly scheduled days off

The tentative contract was presented to the represented members for ratification on February 9, 2023.

BACKGROUND: LTD's current ATU Working & Wage Agreement was effective July 1, 2018, through June 30, 2021. Due to COVID, it was mutually agreed to extend the agreement for one year through June 30, 2022, with an agreed upon wage increase.

CONSIDERATIONS: The Board has met in executive (non-public) session to receive an update on negotiations and the status of the tentative 2022-2026 Collective Bargaining Agreement.

ALTERNATIVES:

- Approve the agreement as presented
- Direct staff to continue negotiations

NEXT STEPS: When approved, the contract will be in effect from July 1, 2022, through June 30, 2026.

RESOLUTION NO. 2023-02-10-006

APPROVAL OF THE CONTRACT BETWEEN LANE TRANSIT DISTRICT AND THE AMALGAMATED TRANSIT UNION

WHEREAS, Lane Transit District (LTD) was approached by the Amalgamated Transit Union's (ATU) to extend the Collective Bargaining Agreement set to expire June 30, 2021 representing LTD's Bus Operators, Mechanics, General Service Workers, Equipment Detail Technicians, Tire Specialist, Customer Service Representatives, Inventory Technicians, Buyer, and Station Cleaner;

WHEREAS, the ATU ratified the new contract for July 1, 2022, through June 30, 2026, on Thursday, February 9, 2023.

NOW, THEREFORE, BE IT RESOLVED that the Lane Transit District Board of Directors approves the Collective Bargaining Agreement between Lane Transit District and the Amalgamated Transit Union effective July 1, 2022, through June 30, 2026.
