

**AMENDMENT THREE  
TO THE INTERGOVERNMENTAL AGREEMENT  
MOBILITY ON DEMAND PILOT PROJECT  
CITY OF COTTAGE GROVE**

**BETWEEN:** Lane Transit District, a mass transit district ("LTD" or "the District")  
**AND:** The City of Cottage Grove ("The City" or "Contractor")  
**CONTRACT NO.:** 2019-07  
**EFFECTIVE DATE:** Upon execution by both Parties

**RECITALS**

**WHEREAS**, LTD issued Contract No. 2019-07, made effective January 14, 2019 to conduct a Mobility on Demand Pilot Project ("the Pilot") in coordination with the City of Cottage Grove;

**WHEREAS**, Amendment One added an additional vehicle to support peak service hours with hours of operation able to be altered, reduced, or extended based upon service needs of the community; and the term was amended to January 1, 2019 to August 28, 2020, or successful completion of the Pilot;

**WHEREAS**, LTD suspended service between March 17, 2020 and August 16, 2020, due to the Covid-19 pandemic;

**WHEREAS**, Amendment Two extended the term until the completion of the Pilot, and increase maximum compensation to \$446,833.00; and

**WHEREAS**, LTD has identified the need and agrees to the changes specified herein.

**NOW THEREFORE**, the Intergovernmental Agreement is amended as follows:


1. **Term** - The term of this Agreement shall be amended to January 1, 2019 to July 1, 2023, or successful completion of the Pilot.
  - a. Period of Performance. The period of performance for the Mobility on Demand Pilot Project is from January 14, 2019, through July 1, 2023.
2. **Invoicing and Payment** - Payment terms are Net 30 calendar days following receipt of a correct and audit-worthy invoice by LTD.
3. **Maximum Compensation** – It is understood by both Parties that Five Hundred Twenty Thousand and no/100 (\$520,000.00), \$260,000.00 delegated for each year, shall be added to the contract value of this agreement to accommodate the extension of the agreement term negotiated with the city of Cottage Grove. It is understood by both Parties that the total maximum compensation shall not exceed **Nine Hundred Sixty-Six Thousand Eight Hundred Thirty and no/100 US Dollars (\$966,830.00)**.

The changes specified herein shall take effect concurrent with the date last signed below. All other terms and conditions of the original Contract and all previous Amendments issued to date shall remain unchanged.
