

## ORDINANCE #97-2

### **An Ordinance Of The Roseburg Urban Sanitary Authority, Adopting The Roseburg Urban Sanitary Authority Code Published by Book Publishing Company And Repealing Section 3 of Ordinance #3, Passed January 12, 1984**

**WHEREAS**, the Book Publishing Company, Seattle, Washington, has compiled, edited and published a codification of the permanent and general Ordinances of the Roseburg Urban Sanitary Authority; and

**WHEREAS**, there is now on file in the office of the General Manager, for public inspection, three copies of a document entitled "Roseburg Urban Sanitary Authority Code";

**Section 1. Adoption.** There is hereby adopted the "Roseburg Urban Sanitary Authority Code", as compiled, edited and published by Book Publishing Company, Seattle, Washington.

**Section 2. Title--Citation--Reference.** This code shall be known as the "Roseburg Urban Sanitary Authority Code" and it shall be sufficient to refer to said code as the "Roseburg Urban Sanitary Authority Code" in any prosecution for the violation of any provision thereof or in any proceeding at law or equity. It shall be sufficient to designate any Ordinance adding to, amending, correction, or repealing all or any part or portion thereof as an addition to, amendment to, correction or repeal of the "Roseburg Urban Sanitary Authority Code". Further reference may be had to the titles, chapters, sections and subsections of the "Roseburg Urban Sanitary Authority Code" and such references shall apply to that numbered title, chapter, section or subsection as it appears in the code.

**Section 3. Reference Applies To All Amendments.** Whenever a reference is made to this code as the "Roseburg Urban Sanitary Authority Code" or to any portion thereof, or to any Ordinance of the "Roseburg Urban Sanitary Authority Code", codified herein, the reference shall apply to all amendments, corrections, and additions heretofore, now and hereafter made.

**Section 4. Title, Chapter, And Section Headings.** Title, chapter and section headings contained herein shall not be deemed to govern, limit, modify or in any manner affect the scope, meaning or intent of the provision of any title, chapter or section hereof.

**Section 5. Reference To Specific Ordinances.** The provisions of this code shall not in any manner affect matters of record which refer to, or are otherwise connected with Ordinances which are therein specifically designated by number or otherwise and which are included within the code, but such reference shall be construed to apply to the corresponding provisions contained within this code.

**Section 6. Ordinances Passed Prior To Adoption Of The Code.** The last Ordinance included in this code was Ordinance #25, passed September 11, 1996.

The following Ordinance, passed subsequent to Ordinance #25, but prior to the adoption of this code, is hereby adopted and made an appendix to this code: Ordinance 97-1.

**Section 7. Effect Of Code On Past Actions And Obligations.** The adoption of this code does not affect prosecutions for Ordinance violations committed prior to the effective date of this code, does not waive any fee or penalty due and unpaid on the effective date of this code, and does not affect the validity of any bond or cash deposit posted, filed or deposited pursuant to the requirements of any Ordinance.

**Section 8. Constitutionality.** If any section, subsection, sentence, clause or phrase of this code is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this code.


