ORDINANCE #2007-01

An Ordinance Amending Ordinance No. 2003-01, Section 1; Establishing Sewer Charges to be Levied on all Users Discharging Wastewater to the Wastewater System, and Declaring an Emergency.

WHEREAS, the charges stipulated in Ordinance No. 2003-01 must be modified.

NOW, THEREFORE, IT IS ORDAINED by the Board of Directors of the Roseburg Urban Sanitary Authority that Ordinance No. 2003-01. Section #1, and hereby is amended to read as follows:

Section 1:

The total rate charged a user shall consist of a charge for debt service, operations and maintenance, repair and replacement of treatment facilities, and collection system.

- a) Because there is no existing bonded debt service, there will be no charge per month for debt service.
- b) The user charge for operations and maintenance, repair and replacement of treatment facilities and collection system will be revised from \$15.75 per month to \$17.00 per month.
- c) For those uses who contribute wastewater with strength greater than domestic sewage, a surcharge, in addition to the normal user charge will be collected.

The surcharge shall be based on the users proportionate share of the operation and maintenance (including replacement) of the treatment works.

The total rate to be charged a class of user based upon this Section is as follows:

<u>CLASS</u>

Residential

\$17.00/month/EDU

II Low Strength \$17.00/month/EDU
III High Strength As determined individually by Calculation
IV Industrial As determined individually by Calculation

Section 2 - Emergency Clause

WHEREAS, the utility billing system has been modified to reflect the new rate effective January 1, 2008, and

WHEREAS, this Ordinance is necessary to establish the rate increase to be effective January 1, 2008;

An emergency is hereby declared to exist and this Ordinance shall be in full force and effective immediately upon passage by the Board of Directors.

PASSED AND ADOPTED by the Board of Directors of the Roseburg Urban Sanitary Authority at its Regular Monthly Board Meeting held on the <u>12th</u> December, <u>2007</u>.
