### **ORDINANCE NO. 2016-01**

An Ordinance Amending Ordinance No. 2009-01, Section 3; Establishing Sewer Charges to be Levied on all Users Discharging Wastewater to the Wastewater System.

**WHEREAS**, the charges stipulated in Ordinance No. 2009-01 must be modified.

**NOW, THEREFORE, IT IS ORDAINED** by the Board of Directors of the Roseburg Urban Sanitary Authority that Ordinance No. 2009-01, Section 3, be, and hereby is amended to read as follows:

#### Section 1

Section 3.04 reads as follows:

The total rate charged a user shall consist of a user charge for debt service and a user charge for operations, including maintenance and replacement of the treatment works.

- a) The user charge for debt service and operations, including operation, maintenance, and replacement of the treatment works shall be \$30.00 for each EDU per month.
- b) For those users who contribute wastewater with strength greater than domestic sewage, a surcharge in addition to the normal user charge will be collected. The surcharge shall be based on the user's proportionate share of the operation and maintenance (including replacement) of the treatment works.

The total rate to be charged a class of user based upon this Section is as follows:

11	Low Strength	\$30.00/month/EDU
