

ORDINANCE NO. 892

An Ordinance to amend the Dalles City Ward Boundaries Ordinance (No. 715), as amended.

THE PEOPLE OF THE CITY OF THE DALLES ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 715 entitled "An Ordinance Redefining the Wasrd Boundaries of Dalles City Pursuant to the Authority Vested in the Council by Chapter 3 of the Charter of Dalles City, and Declaring an Emergency," passed and approved July 19, 1954, as amended, is further amended as follows:

Section 1. Under and by virtue of Chapter 3 of the City of The Dalles vest in the council the power to change the boundary limits of the wards of the City of The Dalles, and in order to conform to the revised precinct boundaries in the City of The Dalles, the City of The Dalles shall be and hereby is divided into four wards designated and bounded as follows, anything in the charter of the City of The Dalles to the contrary notwithstanding:

Ward No. 1. The first ward shall consist of all that part of the city of The Dalles lying westerly of a line running from the intersection of the northerly city limits line and the northerly extension of the center line of Pentland Street, along said center line of Pentland Street and the northerly extension thereof to its intersection with the center line of West Eighth Street, thence westerly along the center line of West Eighth Street to its intersection with the centerline of Bridge Street, thence southerly along the center line of Bridge Street to its intersection with the center line of West Fourteenth Street, thence easterly along the center line of West Fourteenth Street to its intersection with the center line of Union Street, thence southerly along the center line of Union Street extended southerly to its intersection with the southerly city limits line. (The boundaries of the first ward are intended to include Precincts 4, 5, 6, and 9.)

Ward No. 2. The second Ward shall consist of that part of the City of The Dalles bounded on the West and South by the boundary of Ward 3, and on the north and east by a line beginning at the intersection of the centerlines of 9th and Union Streets, extending thence along the centerline of East 9th Street to its intersection with the centerline of Washington Street, thence northerly along the centerline of Washington Street to its intersection with the centerline of East 8th Place, thence easterly along the centerline of East 8th Place to its intersection with the centerline of Case Street, thence northerly along the centerline of Case Street to its intersection with the centerline of East 8th Street, thence easterly along the centerline of East 8th Street to its intersection with the centerline of Kelly Ave., thence southerly along the centerline of Kelly Ave. to its intersection with the centerline of East 9th Street, thence easterly along the centerline of East 9th Street to its intersection with the centerline of Clark Street thence southerly along the centerline of Clark Street to its intersection with the centerline of East 12th Street, thence easterly along the centerline of East 12th Street, to its intersection with the centerline of Dry Hollow Road, thence southerly along the centerline of Dry Hollow Road, to its

intersection with the extension of the centerline of East 15th Street thence easterly along the centerline of East 15th Street to its intersection with the City limits. (The boundaries of the 2nd Ward are intended to include precincts 10, 14, 15, 16, and 19).


Ward No. 3. The third ward shall consist of that part of the City of The Dalles, bounded on north by the Citylimits, on the west by the boundary of Ward No. 1, and on the east and south by a line beginning on the northerly extension of the centerline of Union Street and extending thence southerly along the centerline of Union Street to its intersection with the centerline of 11th Street, thence easterly through the campus of The Dalles High School and along the centerline of East 11th Street to its intersection with the centerline of Kelly Ave., thence southerly, along the centerline of Kelly Ave. and its extension, to its intersection with the centerline of Scenic Drive East, thence easterly along the centerline of Scenic Drive East, to its confluence with the City Limits. (The boundaries of the 3rd Ward are intended to include precincts 3, 7, 8, 11 and 12.)

Ward No. 4. The fourth ward shall consist of all that part of the City of The Dalles lying easterly and northerly of the boundaries of Wards 2 and 3. (The boundaries of the 4th ward are intended to include precincts 1, 2, 13, 17, and 18.)


