

ORDINANCE NO. 364

AN ORDINANCE ANNEXING A CONTIGUOUS AREA TO THE CITY OF PHOENIX, OREGON

WHEREAS, by Ordinance No. 360 the City Council of Phoenix, Oregon, dispensed with an election within the City on the question of the annexation of the hereinafter described property contiguous to the said City, and fixed January 7, 1974, at 7:30 o'clock P.M., in the City Hall of said City as the time and place for a Public Hearing thereon; and,

WHEREAS, the Notice of time and place of Hearing was given by Publication thereof in the Medford Mail Tribune, a newspaper of general circulation, and by posting said Notice in four (4) public places in said City for a like period of time; and,


WHEREAS, at said time and place the registered voters of the City of Phoenix were given an opportunity to appear and be heard, and prior to the time of said Public Hearing the owners of all the real property proposed to be annexed consented in writing to the said annexation and filed the same with the City Council;

NOW, THEREFORE, THE CITY OF PHOENIX ORDAINS AS FOLLOWS:

SECTION 1. The parcel of land contiguous to the City of Phoenix in Jackson County, Oregon, described in Exhibit "B" attached hereto is hereby proclaimed to be annexed to the said City.

SECTION 2. The City Recorder is hereby authorized and directed to make and submit to the Secretary of State of the State of Oregon, a copy of this Ordinance, a copy of the Statement of Consent from the landowners of the tract annexed, and a copy of Ordinance No. 360 dispensing with the election on the proposed annexation; and the City Recorder is authorized and directed to submit a copy of this Ordinance to the County Assessor and the County Surveyor of Jackson County, Oregon.

Commencing at a point from which the Southeast corner of Donation Land Claim #41 Township 38 South, Range 1 West, Willamette Meridian in Jackson County, Oregon bears North $81^{\circ} 53' 13''$ West 242.27 feet distant; thence South $43^{\circ} 13'$ East 702.30 feet to the true point of beginning; thence North $45^{\circ} 42'$ East 437.91 feet; thence North $43^{\circ} 28'$ West 4.81 feet; thence North $46^{\circ} 45'$ East 262.50 feet; thence North $45^{\circ} 42'$ East 350.0 feet; thence South $43^{\circ} 28'$ East 34.09; thence South $44^{\circ} 56'$ West 436.12 feet; thence South $45^{\circ} 42'$ West 614.40 feet; thence North $43^{\circ} 13'$ West 40.00 feet to the point of beginning.
