Hi Chad and Jack,

We understand that the additional information and updates requested by DEQ in the August 11, 2023 letter were extensive, and appreciate that Eagle Foundry has been expending significant resources to complete source testing and gather additional information to respond to our information requests. Eagle's continued collaboration and communication with DEQ throughout the CAO process have demonstrated that the facility is making progress on the submittal. In the interest of giving Eagle Foundry time to complete a thorough review and submit a high-quality Inventory, CAO will grant an extension of the due date for the revised Emissions Inventory, to January 10, 2024.

In the future, when making extension requests please provide specific evidence of (a) the progress demonstrated in completing the submittal and (b) the "good cause" necessitating the delay, as required under [OAR 340-245-0030](#)(3), and ensure that the requests are made by no later than 15 days prior to the submittal due date. Also, in most cases, staff vacations and holidays are not typically acceptable criteria for not meeting a due date when the request was made several weeks prior.

MFA and Eagle Foundry Company received your approval for the Eagle Foundry source test on Monday, November 20, 2023. We are making excellent progress with incorporating the revised emission factors and preparing responses to your letter detailing additional information that is requested. We understand that the revised Emissions Inventory is currently

due on December 20. The additional information requested is quite extensive and is inextricably linked to preparation of the Emissions Inventory. Although we have been working on it for some time, the entire first week, after the source test approval, was lost due to a number of people being out for the Thanksgiving week.
