Dear Mr. Martin:

Shearer's Foods operated a food processing facility and manages industrial wastewater and solids under WPCF Permit #101438. DEQ reviewed the 2023 annual report provided by the facility in conjunction with the final decommissioning report provided as part of closure of operations.

Based on this reporting, DEQ has documented the following violation of Oregon environmental law. With this violation, Shearer's Foods failed to comply with the terms and conditions of WPCF Permit #101438, which is a violation of ORS 468B.025(2).

Violation #1: Exceeding the evapotranspiration rate for a crop during the 2023 growing seasonSchedule A, Item 9 of the permit states "During the growing season, hydraulic loading shall not exceed the crop-specific evapotranspiration (ETc) rate reported at Hermiston Agrimet (HRMO) on a monthly basis."

The annual report states that the ETc rate was exceeded at field B-1 in April 2023. Irrigation occurred only with supplemental water with reported value of non-detect for Total Nitrogen concentration. Soil moisture hydrographs do not indicate irrigation caused leaching past the root zone of the crop. The following excerpt is from the 2023 annual report, Page 4:

Permit Compliance

Effluent water was not applied to the farm; however, field B-1 crop Specific ET exceeded hydraulic loading (hydraulic loading = irrigation + precipitation) by 0.15 inches in April.

This is a Class II violation. See OAR 340-012-0053(2).

Corrective Action Required

No additional corrective actions required as the facility is no longer generating process wastewater and has performed decommissioning activities and requested termination of the assigned WPCF permit. Land application of wastewater has ceased at the 301 acres covered by the wastewater permit. DEQ has approved the requested termination of the permit.

Class I violations are the most serious violations; Class III violations are the least serious.

Summary:

This notice is a warning letter. At this time, the Department does not intend to take formal enforcement action. However, should you repeat this violation, the matter may be referred to the Department's Office of Compliance and Enforcement for formal enforcement action, including assessment of civil penalties and/or a Department order. Civil penalties can be assessed for each day of violation.

If you believe that any of the facts in this Warning letter are in error, you may provide information to me at the address shown at the top of this letter by March 31, 2024. DEQ will consider new information you submit and take appropriate action.
