Dear Carol Glover:

The Oregon Department of Environmental Quality (DEQ) is providing oversight for the investigation and cleanup of a release of gasoline and diesel from the Carol Glover BP property. DEQ is notifying you of its proposal to issue a no further action determination for this site. DEQ issues a no further action determination when a cleanup has met regulatory standards under Oregon's Cleanup law.

Based on our review of site information, DEQ has determined that site conditions are protective of public health, safety and welfare, and the environment under the Oregon Environmental Cleanup Law and Oregon Administrative Rules 340-122-0205 through 340-122-0360. This determination is summarized in Apex's closure report titled *Site Cleanup Report, Carol Glover BP, Yamhill, Oregon*, dated January 30, 2024.

Low concentrations of contamination remain in portions of the site. The contamination consists of gasoline and diesel and is located in subsurface soil 5 feet below ground surface (bgs) and groundwater at 13 feet bgs.

DEQ is notifying you of its proposal to issue a no further action determination due to your recent interest in the site and as a former owner of the property. We will consider any comments that you may have before finalizing the decision.
