Good afternoon,

I have completed their annual inspection for this year and they have a somewhat complicated site.

They have two ponds that collect water.

Sandbags are around the ODOT pipe due to it back-flowing on to their property occasionally. They did this so they could get a representative stormwater sample for their site without comingling.

They did have an event on their site about September-November timeframe where their private pipe from a pond was clogged and flooded their yard. They fixed that situation around November.

Due to a NEDC suit, they installed a temporary Clear Creek Systems unit to treat all of their stormwater before it enters the ODOT pipe. Everything goes through that system and is directly discharged into the ODOT pipe that runs under the 205.

All records indicated that they are maintaining their stormwater infrastructure properly.

I can request photos from Stacy if you need them.

Hi Kathy-

Curious if you have latest stormwater permit info on <u>Myers Container</u>, <u>just east of 205</u>. 10103 NE Marx St. Another DEQ'er got a call today from ODOT saying that the I-205 culvert is plugged and

water is pooling @ Myers Container. ODOT would like to remedy the plugged culvert by the end of the month. We are working with them to understand how the culvert cleanout might occur to minimize impacts to Johnson Lake.

ODOT seemed to suggest that material from Myers container may be part of the problem, since that is what happened in the early 2010s. I know Myers installed onsite stormwater infiltration ponds and treatment as a part of the DEQ cleanup project in ~2014. DEQ hasn't been on site since that time, that I am aware of. Does your team have any recent inspection records @ Myers to determine if stormwater infrastructure is being maintained adequately on site?
