Legislative Redistricting:

City Recorder Ryan and Mid-Willamette Valley Council of Governments Planner & GIS Specialist Kim Sapunar presented on the proposed legislative redistricting. Redistricting was done every 10 years to rebalance the population into equal districts. They discussed the redistricting process and requirements, additional considerations, current districts showing the deviation from the target population, and development of the alternatives. Three alternatives had been developed. Alternative 1 had minimal change, Alternative 2 had minimal change with Districts 2 and 3 close to unchanged, and Alternative 3 would keep the dividing line along Hwy 99 between Districts 5 and 6 and matched the population between districts very closely. They showed maps of the alternatives and gave summaries of the populations for each. They discussed the race and ethnic analysis including maps of the current districts and alternatives, census data discrepancy, and next steps.

CITY MANAGER REPORT

CMPT Worthey gave an update on Fund 31, Admin Services. At this time the fund was \$162,000 over budget. There was also a structural deficit in Fund 31 of \$201,000. NEW BUSINESS

City Attorney Walker reported on the national opioid litigation. Settlements had been reached with three of the distributors and one manufacturer. Distribution to the State of Oregon was about \$21 million from the distributors, and \$325 million from the manufacturer. The allocation of funds was 45% to the State and 55% to local jurisdictions. Signing on to the settlement agreement would mean the City would waive its rights to bring claims against these companies. Newberg would receive about \$721,000 over several years and it would have to be used on measures to combat the opioid crisis.
