Mid Willamette Valley Council of Governments:

Scott Dadson, new MWVCOG Director, introduced himself. He discussed the history and structure of the COG, the programs and services they provided, and future challenges/initiatives.

There was discussion regarding the services provided for a UGB expansion, services provided to School Districts, and makeup of the Board.

Fireworks Ban Discussion:

City Attorney Walker gave an update on the fireworks ban. The Council met in an emergency meeting on July 2 and passed a fireworks ban and declared a state of emergency in response to the high temperatures and dry conditions. The ban and declaration were ratified on July 6 by resolution. Police responded to calls about fireworks, but no citations were issued. The declaration was set to expire on August 1 and the ban to expire today. He asked how to proceed. Tualatin Valley Fire & Rescue District Chief Kennedy said there were no firework related fires in Newberg or the surrounding area. He thought the ban was successful. Police Captain Ferguson said calls were greatly reduced from previous years. Of the complaints they responded to, no one was aware of the ban and complied when asked to stop.

There was discussion on extending the state of emergency, excluding the Old Fashioned Festival fireworks done by a professional, and adding this to the Business Session agenda under New Business.

Polly Peterson and Molly Olson, Newberg Downtown Coalition, presented a final report on the Downtown Enhancement – Community Support Grant. They discussed how downtown businesses had been helped through the pandemic. It was a critical time, and the grant allowed the Coalition to continue to exist. The three goals of the Coalition were: helping develop the Urban Renewal plan and building strong support for it, driving the economic development of Newberg through the Newberg Economic Development Strategy (NEDS) committee, and developing a diverse downtown business inventory. Other work included a parking study, and helping businesses survive during COVID-19.

Josh Duder, Chehalem Valley Chamber of Commerce, presented their Quarter 4 Visitor Center Report showing an uptick in visitors. He had submitted his resignation as interim director to give the Chamber a chance for a fresh start with a new director.

CITY MANAGER REPORT:

Assistant City Manager Wanner reported on library hours and events, Community Development activities, Human Resource recruitments, hiring a new Finance Manager, and Public Works activities. Mayor Rogers discussed the gas leak at Crestview Crossing and feedback from the community.
