I: A Call To Order - The Newberg Area Cable Commission was called to order at 7:00 P.M. on Tuesday, June 16, 1998, at the Community Access Station, at 406 E 1st St. Newberg, OR 97132.

II: Scott Headley addressed the issue of the motion for a digital camera to be purchased that appeared in the May meeting minutes. The motion was to read that the commission would make a request for the money to be provided by TCI for the camera, not that it had been approved. TM clarified this issue and covered the existing finances of the commission. KM suggested that the camera request be added to the renegotiation of the franchise. Scott addressed the concern as to the length of time negotiations may take. It was decided that any immediate equipment needs could be paid for out of the city budget.

III: Report on Renewal of Franchise-TM went over the I-Net survey provided by Stephen Jolin. It was decided that each member would get a couple of volunteers to make contacts to get the survey completed. Scott Headley will approach Newberg Schools, Jack Eichhorn will approach Chehalem Parks & Recreation, TM will address government offices. The members reviewed the survey and decided no additions needed to be made. TM stated that he would like the surveys returned by 6/30/98 or follow up calls need to be made.

KM covered the difference between I-Net and @Home, I-Net is more institutionalized and @Home is more consumer friendly. @Home is a product that will eventually be accessible through TCI. KM explained that TCI would be willing to look into bringing I-Net to the city at a cost. She would like Andy Beecher(TCI) to present the information to the Cable Commission.

TM stated that when the I-Net, financial, performance, and customer service reports are finalized by Stephen Jolin an executive meeting with the City Council needs to be held to address a strategy for negotiations of the franchise proposal.

The Cable Commissions role in this would be to organize the proposal and to keep things in line with the McMinnville Cable Commissions' strategy.

SH would like Stephen Jolin to make recommendations available to the Cable Commission. JE suggested a joint meeting before the proposal is presented. HM suggested they speak to Stephen Jolin on that issue.

TM addressed the agenda provided by Stephen Jolin and will get an updated time frame. The city council would not be able to review a draft until August. KM stated that the franchise for Lafayette was only extended until 7/12/98 in an attempt to hurry the negotiations.

SH addressed the issue that other cities are not showing a lot of involvement and questioned whether or not the issue is a priority to them. KM met with Nan Mileo of Dayton and she felt that not enough progress has been made.

HM will follow up on Stephen Jolin's schedule and get clarification on Scott's questions.

IV: Local Community Access

Volunteer Update - TCI 9 volunteers Ethan and Josh Boyles have been promoted to directors.

Programming Update - This week, TCI 9 will be on the air with 95 hours of actual programs (not including bulletin board). Of the 95 hours, 84 hours broadcast are locally produced programs in Yamhill County. This represents 88% of TCI 9 on-air time.

JE addressed the issue of staffing on weekends due to the fact that their was a blank program on last weekend. This will be looked into by TCI.

SH stated that he has been noticing problems with the reception on TCI 9. KM will have a technician check into that problem ASAP.

V: Community Access Channel

Update from McMinnville - from Frank Nelson:

- They are very happy with the new drapes.
- The electrical outlets are complete.
- They are having problems with the text inserter.
- They would like a separate area for editing and for taping shows.

June 25th is the next McMinnville Cable Commission meeting at the Community Center at 7:00PM.

A request will be drafted for funding to join the Alliance for Community Media and to send 2 members to the conference 7/8/98-7/11/98. SH made a motion for someone to attend the conference and HM seconded the motion. HM said he would attend the conference and SH will check with the other members to see if they would like to attend. The price per person to attend the conference is \$455.00 for all 4 days.

Dan Cochran purchased a copy of the "Best of the Northwest Video Awards" and Thomas will be playing it on TCI 9.

Non Profit Organization -

- Newberg will work with McMinnville to check into the Non-Profit. McMinnville
 is in the process of seeking attorneys to check into this.
- TM suggested to meet with Stephen Jolin and try to stay even with McMinnville's steps.
- Dan Cochran believes they will be separate Non-Profit organizations. HM agreed they should be separate.
- TM has obtained information and will continue to look into it.

Capital Equipment Update- Thomas Coulter will determine short term and long term equipment needs.

Attachment from Harry Morter:

KM objects to any announcements or name changes being done while in negotiations for franchise.

HM stated the attachment was just for the Cable Commission members and that the City Council will have to pick up some of the burden of running TCI 9 so they should be aware of the changes that are happening.

SH believes we need to inform the City Council and also sell them on local access funding.

The concern was addressed as the whether the 2% franchise fee increase would be enough to run local access if the city would not be willing to help. KM stated that it was.

HM would like to change the name and KM said that would be fine if the Non-Profit organization was formed. TM suggested when the Non-Profit is formed publicity be made. KM believes the Non-Profit formation would help negotiations. The commission will check with the cities of Dayton, Dundee, and Lafayette to determine their involvement. HM asked if Yamhill and Carlton could be part of the Newberg Non-Profit. KM stated that Yamhill already gets a 5% franchise fee and may not want to part with it.

VI: Continued Business

JE wants an update on Newberg Old Fashioned Festival and would like to have a booth at the park for a live feed. Thomas Coulter, Harry Morter, and Jack Eichhorn will work on a game plan for the Old Fashioned Festival.

SH asked that Jack Eichhorn and Thomas Coulter form a subgroup of volunteers for the festival and make sure scheduling is taken care of ahead of time.

TM suggested that TCI 9 provide meals for the volunteers. JE will provide him with a request for the money.

VII: New Business - At this point the members summarized their list of things to do.

VIII: Schedule of Meetings: The next meeting will be held Tuesday, July 21st at 7:00 P.M. at The Local Community Access Station at 406 E 1st St. Newberg, OR 97132.



Yamhill County Public Broadcasting



As of January 1, 1999 TCI Channel 9 will no longer exist. Up until this time the FCC has mandated that the franchise cable company provide a studio and equipment for local access. The rules have changed. TCI, our local cable franchise holder will no longer staff and maintain a facility for originating and delivering local programs.

The cities of Carlton, Dayton, Dundee, Lafayette, McMinnville, Newberg and Yamhill will be affected. Your local cable commissions are working on a solution to maintain our local access. There are a few options available.

One option is for the cities to take over the facility and operate it as a city department.

Another option is to form a non profit corporation for the purpose of providing local cable access coverage.

The third option is to do nothing and let community access be a thing of the past.

The cable commissions of the Newberg and McMinnville areas are both working towards forming non profit corporations to continue the service. At present we are undecided whether to form a single corporation representing the entire seven cities or whether to form two entities. As it stands now the McMinnville entity would be for McMinnville, Yamhill and Carlton. The Newberg entity would be for Newberg, Dundee, Lafayette and Dayton. There are some advantages for a single unit in better equipment, fewer employees and uniform programming over the county. Our first step is to draw up some operating parameters to try to fill the needs of each of the cities.

Issues To Resolve

- 1. Newberg, McMinnville and other cities forming a single non profit corporation.
- 2. We need to pick a name for the new channel.
- 3. Do we need city approval for the formation of a non profit corporation before the corporation is formed?
- 4. We need to finalize an operating budget.
- 5. How do we figure the amount each city contributes to the operation of the facility?
- 6. Is the fiber optic infrastructure a responsibility of TCI or the city of Newberg?
- 7. Get commitment from all cities involved.
- 8. Resolve all of the above and present to city councils.

Newberg/McMinnville Corporation

- 1. If we have a single corporation will there be two studio locations or only one in a common location such as Dayton or Lafayette?
- 2. Will we be able to stay open more hours at a single location?
- 3. The single corporation would be governed by a board of directors with a representative from each of the cities. The attributes of the directors should be that all of the disciplines are represented such as religious, financial, legal, social and business to name a few.
- 4. An operating budget will be proposed and each of the cities will share in the expenses. Each city will contribute a share equal to its share of TCI cable subscribers.

Corporation/Channel Name

1. One of the board members has suggested that we do not use the word access in our name. We would encourage anyone to submit a name. We have used Yamhill County Public Broadcasting only as an example.

City Approval

Our legal advisor states that we do not need prior city approval to form a non profit corporation. If we intend to obtain all or part of the operating costs from the cities involved we should keep them abreast of all negotiations.
