1. CALL MEETING TO ORDER:

1.1 Review and approve minutes of August 27, 1996

By consensus, minutes were approved as corrected.

2. OLD BUSINESS:

2.1 Memorial Park Gazebo

Bob Weaver indicated he attended the Planning Commission meeting and felt that the approximately thirty persons in attendance were misinformed regarding the gazebo.

For the benefit of those present, Fisher read a letter in support of the gazebo which he was planning to send to the Graphic as a letter to the Editor.

Weaver questioned why committee was not forewarned that a gazebo might be considered an illegal use. Knight explained that a question exists regarding whether or not a gazebo is a specific use that is allowed in the park. Cole said the project was approved by the City Council but had not been approved by the Planning Commission.

Proctor stated that decisions regarding structures in the park have not been handled in a consistent manner.

John Knight reported on the Planning Commission meeting. The issue of the gazebo

was divided into two distinct parts, that of (1) use and (2) structure. He indicated that most people testified regarding use. Regarding "Structure," the Planning Commission voted 6-1, that the gazebo did not fall under a conditional use or conditional permitted use and recommended the matter be sent to the City Council, with the recommendation that it be allowed as a conditional permitted use. The second part of their deliberations regarding "Use" was tabled.

Marge Stiefbold suggested the matter be sent to a vote of the people to determine what the citizens want.

Duane Cole indicated that the issue of what is allowable in city parks is a policy matter that needs to be discussed and resolved. He noted there are other upcoming issues, i.e. ball parks at Crater, etc., that will have to be examined.

Knight confirmed that if the matter of the gazebo goes to City Council, and if the request is approved and the change is made, the matter will then go back to the Planning Commission.

Bob Weaver complimented John Knight on his handling of the Planning Commission meeting.

2.2 Francis Square

Larry Anderson reporting. He said that lighting and irrigation lines have been drawn. The landscaping areas are about to be dug out and backfilled. He requested guidance from the Committee on how much they wish to accomplish this year. He suggested that volunteers could plant the shrubs, and Staff do the seeding and concrete stamping.

Consensus of committee that the use of volunteers would be appropriate and that Larry should set a date and advertise for volunteers. Regarding the use of brick vs. stamped concrete was left to Larry and Staff's expertise.

3. NEW BUSINESS:

3.1 Consider canceling November and December meeting due to seasonal holidays

There was no objection raised to Chairperson Weaver's suggestion to cancel the November and December meetings due to conflicts with seasonal holidays.
