

## NPD Promotes 4th Patrol Sergeant

Detective Brian Casey has been promoted to the position of Sergeant following a rigorous Assessment Center evaluation by outside evaluators and an in-house evaluation.

Casey began his career at the Newberg Police Department as a Reserve Officer in 1990. Hired full time in 1993, he was promptly assigned to the Detective division where he has spent the last five years. Casey will continue his current assignment as Youth Crime Detective until the end of the school year. In addition, you'll see him in full uniform as he assumes his duties of day shift Patrol supervisor.

The Assessment Center was comprised of four police officers, ranking from Sergeant to Chief. The Assessment Center involved a cooperative group exercise, situational role playing, a written practical exercise and an oral interview. All five Newberg officers who participated in the process received high marks from the assessors and the final decision was reached only after long difficult deliberation. (Goal 8)



### **NPD Hiring**

The Newberg Police Department recently advertised for vacancies for the positions of 9-1-1 dispatcher and police officer.

Forty applications were received for the dispatcher position and 107 for police officer. Testing is currently underway and oral interviews will be arranged for those passing the minimum requirements for the positions. A hiring list may be created to fill any future openings occurring in 1998.

These vacancies exist as a result of the departure of Dispatcher Davis Randell and Officer Chris Divine, who took positions with the Microsoft Corporation in Redmond, Washington, and Police Officers Shane Nicholson and John Clinton following their hire at the Portland Police Bureau. We wish good luck to all of these fine employees. (Goal 8)

# **Public Safety Facility Dedication June 2nd**

A formal dedication ceremony of the Newberg Public Safety Facility has been scheduled for the afternoon of June 2nd, followed by refreshments and tours of the new facility. 
# Mandatory Inservice Training
