## CALL MEETING TO ORDER:

Weaver called the meeting to order.

## 1.1 Review and approve minutes of September 29, 1998.

Minutes will be placed on file as corrected.

## 2. OLD BUSINESS:

## 2.1 Francis Square Update

Russ Thomas gave a brief report on the Francis Square project. New blue benches were installed yesterday. They are bolted down, and have two coats of paint for UV protection and to protect against carving. Trash receptacles will be ordered. Winter weather flower baskets will be hung. The flagpole is completed and the plaques have been affixed to rocks procured from Crabtree Rock. Larry Anderson will looking into an informational kiosk, and getting design plans for a shelter. Anderson is considering a shelter based on the preliminary designs, L-shaped in the corner using brick and blue.

Committee members are receiving positive feedback from citizens.

Thomas noted that the owner of the Antique Mall asked that the hedge be trimmed to make their sign more visible. Thomas reported that the hedge is trimmed as much as possible and that the hedge is planted specifically to separate the alley from Francis Square.

Per Mayor Proctor, the official dedication ceremony for Francis Square will be held Veteran's Day, November 11, 1998, at 10:00 a.m. Becky Manning will send invitations to all donors and volunteers who helped develop Francis Square. Proctor is coordinating the event.

## 2.2 Gazebo Garden Update

Chamberlain said the plantings around the gazebo are doing very well. Meyer concurred, and noted that the paint on the Gazebo is still looking good.

Thomas indicated that a temporary pathway composed of bark dust wood chip will be installed east-to-west until the grant is approved or until Staff decides how to proceed on the project. The site will need considerable grading before a more permanent pathway can be installed. Chief Tardiff asked if the temporary pathway will satisfy the Building Inspectors so the Public Safety Building can get their occupancy permit. Beam indicated that his understanding is that the gazebo landscaping superceded the Public Safety Building landscaping and should not hold up the occupancy permit.

## Rules and Regulations for usage of Francis Square and Gazebo 2.3

Weaver suggested developing rules and regulations for the usage of Francis Square and the gazebo as a new goal for the Community Relations Committee. These need to be developed and then adopted by the Newberg City Council. Weaver envisions a subcommittee, meeting outside of regular meetings, will develop the rules and regulations.

## 3. **NEW BUSINESS:**

## 3.1 "Welcome to Newberg" signs

Soderquist indicated that PGE has donated \$1500 towards the development of a new "Welcome to Newberg" sign to be posted somewhere out towards the airport. The City will need to budget approximately \$5000 towards a new sign to meet the total cost of approximately \$7000. PGE would also provide the concrete foundation and sides. The City needs to provide the carved sign. Besides the sign itself, the project needs to take into consideration the landscaping, water, lighting, etc.

Smurfit checked out the existing signs and declared them in good condition.

## 4. OTHER:

## 4.1 Information Sharing

Duane Cole is following through on the City flags. Phone calls are not being returned by the vendor. It was reported that the vendor has been ill. Weaver asked that this issue be put on the next agenda. In the meantime, Donna Proctor will ask the City Manager to send a communication to Committee members on the status of the flag project.

Dick Meyer reported that the downtown merchants will be open to trick-or-treaters again this Halloween. They are looking for volunteers to assist as crossing guards. There will

- The library is planning a day of activities for children, with a book sale, kids' craft sale, and visiting authors.
- Look for the mural of story characters and the Newberg quilt in the main meeting room. The wall space was needed for more shelving and these features had to be moved.
- The new long-range plan for the next five years has been developed was distributed to the City Council.
- The Library Friends donated \$4000 for the initial phase of lighting upgrade. They
  are still looking for additional funding for more lighting and will be pursuing a fundraising campaign strategy.

## Police:

- Red Ribbon Week being celebrated this week, with a city-wide rally being held today at 10:00
- The current Police Citizens Academy will graduate next Tuesday evening. Has been a very good group, with active participation.
- Cindy Bolek was asked to make a presentation at the ODOT Traffic Safety Conference on the Public Safety Announcement videos that she and Frank Douglas have been producing.
- OLCC and the department held a meeting where the decoy program was explained; over sixty persons were in attendance.
- A new bicycle ordinance will be heard soon at the City Council. The Traffic Safety Commission reviewed the ordinance and made a few changes before recommending adoption by the City Council.
- Newberg Police officers are trained and current in CPR. Frank Douglas is working with the police department to put an automatic defibulator in the patrol vehicles.

## Fire:

- Three volunteers finished paramedic school
- Readying for the ISO review
- City Council awarded a contract for a new fire truck
- Station #2 has new pavement and abestos is being remved from Station #1 Discusson on the new smoke detectors. Fire Department only installs smoke detectors for the indigent. When the cost of the new detecors goes down, the Fire Department expects to renew their program. Weaver suggested that one of the service clubs might take on smoke detectors as a new project.

## **Community Development:**

Marge Stiefbold questioned the City's standing on new Federal requirement that water quality statements be published for any municipal agency with population over 10,000.

Weaver noted that the holidays fall near the meeting dates for November and December and suggested that the next two meetings be canceled.

2.1 Memorial garden and cost estimates

## 2.2 Grant money for garden at gazebo

Jadene Torrent is working on a conservation plan for the garden. A plan was displayed. Garden will be landscape intensive, and have irrigation, lighted pathways, a kiosk to provide brochures on plant life. It is planned as an educational garden, providing the public with information they can use in their personal gardens. Ms. Torrent indicated the project is designed to showcase different plants suitable to minimum water usage. The project is estimated to cost approximately \$87,700.00. David Beam is working on a grant application to the Spirit Mountain Grande Ronde Tribes. He noted that the irrigation and use of mature plants added to the cost.

Mayor Proctor expressed concern over the cost. Cole indicated the figure is a budget estimate for applying for the grant. Better to ask for too much and be able to reimburse

unneeded funds than to underestimate the cost and end up with a shortfall. He indicated that actual cost estimates will be calculated.

Weaver was delighted the garden will be used as a teaching tool and that the plantings will be identified for the casual observer.

## 2.3 Complete Francis Square before year-end

Chairman Weaver thanked Russ Thomas and his crew for installing the flag pole.

Larry Anderson presented ideas for a cover for the tables to be located on Francis Square. Vendor is from Salem and the Scottsdale Model was recommended. There was generous discussion. Beth Carlson preferred the Denver model, noting she did not like the cupola on the Scottsdale model. Stiefbold suggested the roof color should be blue, coordinating it with the fountain. Donna Proctor agreed with the blue color, but suggested that the brick on the Denver model would not blend with the brick in Francis Square. Dick Meyer suggested the Scottsdale model resembled a car port.

Weaver gave Larry Anderson the "green light" to develop a plan for a cover which would accommodate the suggestions presented. Anderson does not want to make the final decision and will do some more investigation on what is available.

## 3. NEW BUSINESS:

3.1 Develop rules and regulations for usage of Francis Square and Gazebo Weaver indicated that the Committee needs to develop some guidelines for the usage of Francis Square and the gazebo. Mayor Proctor indicated that amplification is not appropriate in Francis Square. Committee members were encouraged to develop some ideas for Duane Cole to take to Staff for development of formal rules.

Just over 17,000 items were checked out in the month which is 3,000 more than we checked out last September. People seem to be responding to the expanded hours with greater use, just what we had hoped for. To celebrate the new hours, we offered a paperback exchange attended by 38 people, a prize drawing, and a Chautauqua program on the life and times of George Washington which had over 60 people attending. Staff are settling into the new hours as well with revisions of tasks and getting used to that 10 am opening time.

## Storytime Starts Again

Storytimes started up again in September for the Fall Season and have been a rousing success with the under six crowd and their parents. We've had 40-60 children at each session. We'll be advertising and hiring to fill the position later in the month.

## Library Board Report

The Library Board met on September 15th. They acknowledged with appreciation the efforts of member James Allgood who was resigning for family reasons. Cherie Taylor was welcomed as new member and they welcomed back returning member David King by electing him chair for the coming year. Debbie Headley was elected vice-chair. Their primary activity was reviewing the Fine/Fee schedule. The changes would be to raise the non-resident fee to \$40 (\$35 for seniors) and implement a fee of \$10 for CCRLS rural residents. This will be discussed and voted upon at their October 20th meeting. The Board will be meeting from now on at 7:00 pm on the third Tuesday in the Director's office due to the modifications in the meeting rooms.

## Director's Activity

The Director attended meetings of the department heads and the Chehalem Valley Senior Citizens Council. She contacted candidates and prepared the Voter's Booth for the fall election with information from Newberg and Yamhill County contested races. ## Public Works Beyond the Call of Duty

Three of our own Public Works employees (Mike Malone, Denny Brown, and Howard Whitman) discovered an apartment complex on fire last month. They quickly contacted the Fire Department and heroically began evacuating the building while the Fire Department was responding. Several residents were injured, but there were no deaths. A job well done by quick thinking folks with big, strong hearts!

Francis Square continues to improve the appearance of Downtown with the recent installation of a lighted flagpole.

The Division replaced an aging 18-year-old sewer service truck. The new truck sports new improvements including: locking tool storage, increased payload capacity, truck racks, and an onboard 110 power supply for power lights and power tools.

Storm ditches have been cleaned west of North Main Street and near A-DEC along the railroad tracks. These two areas have caused localized flooding during heavy rains in the past due to partially blocked drainage

ditches. More cleaning and inspection of ditches are being done in preparation of winter rains.

A water system hydrant survey has been completed. The Division has prepared an initial draft of the hydrant maintenance/flushing program, in conjunction with Fire Department personnel. The Division has also completed exercising of all fire hydrants, and repairs to insure operation of the system.

A section of the Riparian water line that had been damaged by a farmer's plow has been repaired. The water line, which was leaking and placed at a shallow depth, was moved and lowered to prevent future damage. The Division repaired an additional eight leaks on City water system lines.

Street sweeping, conducted on a daily basis, continues to average more than 250 curb miles per month. An average of one cubic yard of debris removed from the road for every four curb miles swept. Removal of this debris helps prolong asphalt street life, prevents clogged storm drains, and prevents it from getting into the area's creeks through the storm drainage system when it rains.

Finally, the record continues . . . the Division has experienced no mainline sanitary sewer blockages during last 210 days. The cleaning and inspection program continues . . .

## Engineering

The City contracted with Colamette Construction Co. to repair the library roof, hopefully before the monsoon season. The Project Manager is John Raineri.





Enclosed you will a completed grant request application for consideration under your Spirit Mountain Community Fund program. This request is made to assist in the funding of a special project planned by the City of Newberg to create a low-water-use demonstration garden in Newberg's Memorial Park. Total cost of the project is estimated at \$92,020. This cost estimate for the garden includes site grading, concrete sidewalks, landscaping, irrigation, and electrical (power and lighting) systems. The amount requested from the Spirit Mountain Community Fund for the project is \$86,000.

We believe that the realization of this project will be an important step in the delivery of information to the public concerning the wise use of our precious water resource. With this purpose in mind, the proposal would most likely best fit within the Education category of the Fund. However, a project like this crosses over into many other fund categories, such as Arts & Culture, Health, and Environmental Preservation.

The Low Water Use Demonstration Garden was designed by registered landscape architect William K. Roth. The proposed layout is depicted on the enclosed drawing. Newberg's water supply has been an issue of increasing concern over the past few years. Recently, the City Council passed an ordinance authorizing the imposition of conservation practices in the community, and, when necessary, water curtailment measures. Part of our strategy is to encourage more efficient water use in home gardens. The low water use demonstration garden will display for the community different groups of plants requiring various levels of irrigation, from conventional varieties to those requiring no irrigation at all.

Significant aspects of this garden project have already been achieved. The City has already financed the landscape architect's fee (\$1,700) for the garden's design plans. Moreover, last year, the City constructed the centerpiece of the garden: a gazebo (at which weddings and other social events will be held). With the donation of materials and volunteer labor, we were able to build the structure for only about \$18,000.

It is important that on the ground work of the garden begin by early May of 1999, as this is the optimal time for construction and landscaping activities. If this start date is realized, the City anticipates that the garden will be completed by July of 1999

If the Spirit Mountain Community Fund could help the City with this project, the community could continue moving forward with development solutions to one of its more vexing problems. In this time of scarce resources, the citizens of Newberg would be grateful to the Confederated Tribes of Grand Ronde for your assistance. We would be willing to express that gratitude by erecting a plaque in a prominent place in the garden, acknowledging the Tribes' pivotal role in making the demonstration garden a reality.
