VII. **PUBLIC HEARING** 

> Consider a motion approving Resolution No. 2007-2715 adopting the City of Newberg Budget for the 2007-08 fiscal year. (Bring material from June 18, 2007, packet)

Legislative

James Bennett, City Manager, gave an overview on the June 26<sup>th</sup> budget committee meeting. He said the committee received the charge from the city council to look again at the decisions made when approving the budget concerning the \$205,000 in cuts. The reasons for the referral were significant testimony cuts to the Chamber of Commerce, potentially restoring other cuts made, and additional property tax revenue received after last budget meeting of approximately \$128,000. The budget committee recommended for the additional tax revue to be used to restore certain cuts made to general fund referred to in the city managers June 22<sup>nd</sup> letter. They also made the recommendation to take balance of the Cable TV Fund and move it to contingencies. This means in order to expend money from that fund it must come back to council in the form of a supplemental budget. The budget committee is in favor of the budget and these changes.

**MOTION: Soppe/Rierson** to move the \$98,803 from the Cable TV Fund to a contingency fund and requiring a supplemental budget for expenditure. (Unanimous) Motion carried.

**MOTION:** Larson/Palmer to accept the recommendations of the budget committee to use the \$127,847 in additional tax revenue to restore the list of prioritized budget cuts as outlined in the City Manager's letter to the budget committee dated on June 22<sup>nd</sup>, which includes \$1,640 for a contingency. (5 Yes/2 No [Soppe, Currier]) Motion carried.

**MOTION:** Palmer/Larson to approve Resolution No. 2007-2715 adopting the City of Newberg Budget for the 2007-08 fiscal year as recommended by the Budget Committee with amendments, making appropriations, levying a property tax, and approving the City of Newberg's participation in the State Revenue Sharing Program.

Discussion occurred concerning the participation of the State Revenue Sharing Program and if it just needed to be part of the Resolution. It was assured by staff that council is covered by mentioning it and the obligation was upheld by the budget committee when it held a public hearing as part of the first meeting.

**VOTE:** To approve **Resolution No. 2007-2715** adopting the City of Newberg Budget for the 2007-08 fiscal year as recommended by the Budget Committee with amendments, making appropriations, levying a property tax, and approving the City of Newberg's participation in the State Revenue Sharing Program. (5 Yes/2 No [Soppe, Currier]) Motion carried.

## X. COUNCIL BUSINESS

**Mayor Andrews** announced he was considering establishing a council subcommittee to come up with overall policies for the evolution of the budget process and those willing to participate should please contact him. He also asked staff to be prepared to begin the budget process as of July 1<sup>st</sup>.

**Mr. Mahr** stated he contacted a representative from McMinnville Community Media (MCM) Cable Channel 11 to set up a meeting to discuss partnership options. He was told Newberg's participation in MCM was welcomed as long as it was on the same level as other cities, which include 100% of the peg fee, \$1 per subscriber per month, and 45% of our franchise fee being donated as well. He did not now if council was willing to participate at that level.

**Councilor Larson** announced at the next Cable TV subcommittee meeting they might invite a representative to come speak with them.
