PUBLIC HEARING: Ordinance 2019-2847

Mayor Rogers opened the public hearing. No declarations of ex parte contacts, conflicts of interest, bias, or abstentions by the Council.

Staff Report:

Planner Owens presented. This was a request to amend the Municipal Code to allow original art murals on public buildings in residential zones. She gave a background on the item and discussed how if approved it would allow murals on 25 public buildings. The Planning Commission and staff recommended approval.

Mayor Rogers closed the public hearing. CA Stone recommended carrying over the second reading of the ordinance to August 19th.

1. Community Visioning Project Update

Staff Report: Community Visioning Coordinator Ware stated there was a Newberg

Community Conference on June 18 to kick off the third survey phase. He explained the results of the survey. The Action Plan for the vision was being finalized and there would be a Big Bash event

on August 15.

Discussion: The Council discussed:

• Implementing the Action Plan and community involvement

• Big Bash event

2. Resolution 2019-3582, Housing Needs Analysis & Strategy

Staff Report: Planner Owens presented. She gave a background on the Housing

Needs Analysis, Buildable Lands Inventory, and needed land supply and housing mix. The Housing Strategy would provide steps to address the unmet housing needs in Newberg. Staff recommended approval of the resolution to accept the Housing Needs Analysis and

Housing Strategy.

Discussion: The Council discussed:

High cost of living in the City and need for affordable housing.

• Options for funding affordable housing projects, such as reducing SDCs, General Obligation Bond, Construction Excise Tax.

• Items in the strategy and balancing staff's workload and their capacity to accomplish the strategy.

- Changing the priority order and moving tiny homes up. Staff did not have the capacity to do this in the 2019-20 year, but could possibly work on it in 2020-21.
- Adding a Managed Manufactured Home Park to the list.
- Finding temporary shelter as soon as possible for those who were displaced in the community.
- Hiring a contractor to do some of the work.

• How growth was changing the feel of Newberg's neighborhoods.

Staff Report:

City Attorney Stone said the Council was being asked to interpret the Code on whether to allow subordination of an SDC payment lien for apartments that were being built on 2nd Street. The City's lien was currently in first position, and they were being asked by the bank to step behind the bank's lien. This would help protect the bank's interest in lending on the construction loan. He explained what this would mean for the City as well as SDC financing and Code interpretation. The applicants had signed an agreement with the City to make payments over 10 years and were current on their obligation and the City had a first position lien to secure that debt. The decision by Council would set a precedent.

City Manager Pro Tem Clyne thought the Council had the ability to approve this request. It would also further the Council's economic development and housing strategies.

Discussion:

The Council discussed:

- First or second position in liens.
- Frequency of these requests in other cities.
- If this was affordable housing or just downtown housing.
- Risk involved with making this interpretation.
- Setting up a policy for this type of request in the future.

Public Comment: Elizabeth McCann, applicant, said the project was to build 19 apartments and one live/work unit. The bank was requiring to hold first position for financing. She asked that the City's lien for SDC financing be subordinate to the construction financing provided by Bank of the Pacific.

Mayor Rogers asked about permanent financing. Andrew McCann, applicant, said once they were 90% filled they could seek permanent financing and at that time they could receive a 60% loan to value. The current appraisal was \$4.8 million and they were investing \$5.3 million. They had been working with City staff on this project, and last minute the bank had required this. Their hands were tied as they needed the bank loan to complete the project.

Deliberation:

Councilor Bacon was in support. If there were more requests, they should be looked at case by case. Mayor Rogers said the loan was substantially below the value of the property.

Councilor Johnson said for future requests, he thought the project should meet a plan including the City's housing goals. This project met the Downtown Master Plan and affordable housing and high density residential needs. Councilor Findley said there was a lack of housing in the City and was in support.

Councilor Corey said after hearing about the loan to value ratio, he was in favor of it. He thought that should be taken into consideration for future requests. It also met the housing need in Newberg.
