#### **PUBLIC COMMENTS:**

Michael Gunn, Newberg resident, discussed the Patton lawsuit and the resulting increase in the City's insurance rates. He then discussed the allegations in the recent sexual harassment case and his qualifications as an attorney.

Rebecca Wallis, Newberg resident, talked about public records requests and lack of responsiveness from the City to her questions. She found it frustrating that the Pro Tem City Manager had run out of PERS hours. The City required full time attention and management.

Mayor Rogers allowed Mr. Gunn 2.5 more minutes to speak.

Mr. Gunn discussed the cost of the lawsuits and risks to the City which would cause insurance rates to rise. He thought Brooks, Casey, and Kosmicki should have been publicly exonerated.

Rebecca Swindle, Newberg resident, discussed PFLAG Newberg's request to fly the PRIDE flag for the month of June. She explained what flying a flag would do for the community.

2. Ordinance 2019-3584, Street vacation of ROW in Fulton Street

Mayor Rogers opened the public hearing and read the hearing script. He asked for any abstentions, bias, ex parte contacts, conflicts of interest, or objections to jurisdiction. None declared.

Staff Report: SP Caines presented the request for vacation of N Center Street right-of-way to allow more flexibility for the second phase of the Friendsview University Village development. There had to be two-thirds of the property owners in the affected area that consented to the vacation, and in this case the adjacent property owners were Friendsview Manor LLC except for one tax lot to the northwest owned by the Cad Living Trust. There was a water line and wastewater line in this right-of-way as well as PGE

and Frontier facilities and the applicant was required to record easements for the City, private utilities and services, and emergency vehicles for access. The ordinance also reflected the sale of the Cadd Living Trust tax lot to Friendsview. Staff recommended approval.
