Sidewalks Discussion:

City Engineer Hofmann explained reasons for sidewalk improvements, current program, public involvement, recent sidewalk inventory, funding needs, identified critical routes that would be priorities, and options for moving forward. She discussed sidewalk grant and loan programs for property owners. City projects would also be done to repair sidewalks, install them where there were gaps, and include them in new projects.

There was a discussion on tree types that would not cause sidewalk impacts, street tree removal and replanting, proactive steps, need based grant program, public education and outreach.

Roy Gathercoal said Newberg had not followed legal requirements on sidewalks. Residents with mobility disabilities could not use City sidewalks safely because of the gaps and lack of ramps. It made many stay in their homes and not be part of civic life.

There was a discussion on priorities and options for the future, identification of primary, secondary, and tertiary critical routes, community outreach, City video shared on You Tube.

Council Rules Discussion:

Mayor Rogers reviewed the Council Rules through a PowerPoint presentation.

CMPT Clyne said at the first reading of this ordinance there was some suggested language to be added regarding a budget restriction, but it didn't make sense to add it. He suggested going back to the ordinance as presented by staff.
