1. May 2006 Election

Discussion was held to decide if May 2006, or if November 2006, election would be better. It was unanimously decided to set as a target to have the Charter revision on the May 2006, ballots (should be Tuesday, May 16,2006). This would require the submission of the ballot measure 60 days ahead of the election (should be Thursday, March 16, 2006). Submission to the Council would have to be earlier with committee recommendation made and submitted in time for council meeting deadlines. James Bennett, city manager, pointed out that there was no rush and the November election could be a "fall back" election. Chair Andrews stated that it was important to establish some tentative time frames/ time targets. The staff could bring back some "target deadlines" based upon the May 2006 election.

Discussion was held on goals and items the committee would like to review and possibly change in the Charter. The preliminary list is as follows:

- 1. Need for Significant Changes.
 - a. Council Boundaries (Section 14) addressing re-districting, having an at-large member(s), removing districts, and procedure when member moves out of their district.

- b. Hospital (Section 43-48) repeal.
- c. Liability (Section 50) repeal.
- d. Public Parks (Section 54) repeal.
- e. Bonds (Section 56) repeal.

2. Legal Issues.

- a. Utilities (Section 4[3]) clarifying definitions and review authority.
- b. Residency (Section 14[a]) clarify definition.
- c. Council Membership (Section 19, 21, 34, 35 and 37) address definition of vacancy, abstention, and entire membership (relates to 1.a.).
- d. Voting and Acting Mayor (Section 20 and 21) clarify.
- e. Canvass of Returns (Section 30) correspond with State law.
- 3. Additions, Changes, Clean up, Improvements.
 - a. Vote for Annexation (Section 3) clean up.
 - b. Compensation (Section 13) clean up.
 - c. City Manager (Section 23) change bonding, improve.
 - d. City Recorder (Section 25) revise or repeal.
 - e. Debt Exemption (Section 53) improve pre-existing debt.
