Review Draft of Pension Investment Policy: Kathy Tri reviewed a draft Pension Investment Policy. She stated that she was interested in feedback from the committee. She was asked about employee involvement in investment decisions. She explained that Principal advises her and the City Manager about investment strategies. Over the years the plan has been diversified. Lou Larson asked questions about the type of annuities which are purchased and Principal's fees.

Update on City Retirement Plan Status: Kathy Tri reviewed the status of the City's retirement plan. She explained that the City received notice from the IRS that the plan would be determined to be in compliance once the City paid some fees and showed corrections had been made. All corrections have been completed and are being documented to the IRS.

Quarterly Report: Kathy Tri presented the fourth quarter report. All the major operating funds were reviewed as well as investments and capital projects. Rebecka Ratcliffe asked about growth projections. Jim Bennett indicated that recent Census numbers showed that Newberg's growth was greater than originally projected. She also asked about sewer rates and if the sewer fund's cash had been restored. Ms. Tri indicated that it would take several years to restore the cash balance to the appropriate level; however the fund balance came out to projected levels. She also indicated that the water fund was also having cash flow problems and it also would take a couple of years to restore cash balances. Donna McCain asked about PGE. Mr. Bennett responded that if Portland took over PGE, the city would have to hire experts to run the company.
