I. Convene NUAMC

The Newberg Urban Area Management Commission convened at 7:00 p.m., February 15, 2001 with the following members present:

Alan Halstead moved to appoint Warren Parrish temporary chair. Sid Friedman seconded, and the commission unanimously consented.

II. DISCUSSION OF NUAMC ROLES

Temporary Chair Parrish asked Planner Brierley for a staff presentation.

Barton Brierley explained that the Oregon Planning System includes creation of Urban Growth Boundaries. Cities and counties are to agree on how to manage lands within the Urban Growth Boundary. The City and County adopted the Newberg Urban Growth Management agreement, and created NUAMC to coordinate city/county issues and to serve the interests of citizens. There are six members on the committee, plus one NUAMC appointed member.

III. APPOINTMENT OF AT-LARGE POSITION

Temporary Chair Parrish asked if the advertisement for the NUAMC vacancy stated the person needed to be present to be appointed.

Barton Brierley said he did not know.

VOTE: The committee voted unanimously in favor of Warren Parrish as vice-chair.

The meeting was adjourned at 7:30 p.m.
