MOTION: Member Findley and Member Olson, Motion to approve the Ad Hoc Urban Renewal Citizens Advisory Committee Meeting Minutes for January 4, 2022, Motion carried 7/0

NEW BUSINESS:

A. Newberg Urban Renewal Plan and Report:

CDD Rux noted since the meeting on January 4th, Elaine and her team, Nick and his team and staff have worked on the Report and Plan which was mailed out a week ago to the Committee. He noted they revised the district boundaries, which is now 540 acres, and it does not include any land outside to the corporate limits. He noted they just finished the final annexation from the Mill site and the Bypass, which went into effect January 19th. Nick went through the financials and the final number is \$125,800,000 with the duration of the Plan is set at 30 years. The maps have been updated to reflect the new legal description.

CDD Rux noted City Council adopted the new Middle Housing regulations for HB2001, so the R1, R2, and R3 language has changed by adding the word Middle Housing, to be consistent with the Comprehensive Plan.

Elaine noted her and CDD Rux read through the Plan and agreed to pull out anything that said "unincorporated" and anything that said, "you're not with the city". The Plan talks about the city limits of Newberg and the fact that Newberg City Council can adopt this on their own. She noted they made the changes to the project and allocations according to the Committees guidance.

CDD Rux noted they did some editorial to the plan, such as spell-checking, punctuation and everywhere a map is showing the boundary they made sure there was a footnote that refers to the legal description, which is the legal boundary of the proposed District. He noted to the Committee that this is the final Urban Renewal Plan and accompanying Report.

Chair Bridges asked for comments on the revision to the Plan and would accept a motion to approve.

MOTION: Member Higgins and Member Olson, Motion to recommend the Newberg Urban Renewal Plan and Report be forwarded to the Newberg Urban Renewal Agency for referral to Taxing Districts and to the Newberg City Council for adoption, Motion carried 7/0

CDD Rux noted they will now go to the Urban Renewal Agency on February 7th. He will submit the staff report tomorrow and asked Chair Bridges if he would be available on February 7th. He has done the outreach to all the Taxing Districts scheduling opportunities for presentations, because they will start the consult confer process on February 10th which will run for 45 days and end on March 28th. They are scheduled to go before the City Council for two meetings in April, the first meeting is a hearing, and the second meeting is the final reading of the ordinance.
