ADDENDUM #1  
THE DALLES MUNICIPAL WI-FI ASSESSMENT  
PROJECT NO. 2024-005

The City of The Dalles is providing this Addendum to clarify the April 3, 2024, Request for Proposals for **Project No. 2024-005 THE DALLES MUNICIPAL WI-FI ASSESSMENT (RFP)**.

This Addendum provides clarifications to the RFP by openly answering questions the City has received on its substance. *None of these responses have resulted in any amendments to the existing solicitation or form of contract.*

- **Q1: Can the awardee of this RFP (feasibility study & design plan) also provide a turn-key solution to include design, installation, and management?**

*A: Yes, the City will prioritize a candidate who would also be able to provide installation and management in the case that the project get the approval to move forward.*

- **Q2: Can you provide a fiber map to go with the table describing the distance of fiber from the service location?**

*A: Yes, a fiber map will be provided upon signing a contract with the proposer.*

- **Q3: Who owns the light poles and traffic signals? Is it the city or utility company?**

*A: The City owns all the light poles and traffic signals in the city.*

- **Q4: Can you provide a list of city facilities (building, water towers, towers, etc.) that show the Fiber access locations?**

*A: Proposers are to ascertain exact fiber connections with Q-Life, our local quasi-government fiber provider, after signing the contract.*

- **Q5: Is there any information of current user density in designated locations?**

*A: The given possible hot spot locations show areas of increased pedestrian flow, but no there is no concrete data on the specific user density within the Required Areas.*

- **Q6: Do the maps provided denote the existing Wi-Fi AP locations?**

*A: The maps provided to the winning proposer upon signing a contract will show the accurate locations with pictures of around 70 APs, those that are not mapped have names alluding to their location but are inside a building or otherwise were not visible when the research was conducted. If needed, the successful proposer will have to verify each AP location as the City cannot promise that they are all accurate.*

- **Q7: Can you provide estimated density of users per park location?**

*A: No.*

- **Q8: Will the Wi-Fi network use existing infrastructure to include fiber switches at fiber access locations, firewalls, DHCP services and other core infrastructure?**

*A: It is up to the proposer to identify what, if any, of the current infrastructure should be reused. The decision should be made to maximize the safety, effect, and affordability of the new system.*
