WHEREAS, the City of Vernonia, Oregon ("City") was awarded a Community Development Block Grant in the amount of Five Hundred Thousand and No/100 Dollars to implement a buy-out program for the demolition of qualifying structures that were substantially damaged as a result of the December 3, 2007 flood event (FEMA-1733-DR) (the "City Grant");

WHEREAS, the Columbia County, Oregon ("County") was awarded a separate Community Development Block Grant ("CDBG") in the amount of Five Hundred Thousand and No/100 Dollars to implement a buy-out program for the demolition of qualifying structures that were substantially damaged as a result of the December 3, 2007 flood event (FEMA-1733-DR) (the "County Grant");

WHEREAS, the County has informed the City that it is not likely that it will utilize 100 percent of the County Grant to acquire and demolish dwellings within the unincorporated area of the County. The County desires to use the remainder of the County Grant toward acquisition and demolition of qualifying structures located within the City. The City lies wholly within the County;

WHEREAS, the Oregon Business Development Department staff has informed the County that it may use County Grant funds under the program, if the County can provide documentation from the City which grants the County the authority to implement and enforce it within the incorporated city limits of Vernonia;

WHEREAS, the City wishes to authorize the County to administer the County grant within the City should the County determine to do so; and

WHEREAS, the City Grant and the County Grant both are administered under separate agreements with the Community Action Team ("CAT").

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF VERNONIA RESOLVES AS FOLLOWS:

1. The City acknowledges that the County has the jurisdiction and authority to implement and enforce the federal and state CDBG program requirements of the County Grant within the incorporated city limits of the City of Vernonia.

ISSUE STATEMENT AND SUMMARY
