Dear Mr. Haglund:

The Oregon Department of Environmental Quality (DEQ) has completed a review of the available information for the Dawson Tract #1 Lift Station site/property, including the 20-day report entitled Initial (Twenty Day) Report Form for UST (underground storage tank) Cleanup Projects dated January 6, 2023, which was submitted to DEQ by BB&A Environmental on your behalf. The Dawson Tract #1 Lift Station address is 1675 Old Highway 101, Tax Lot 40S14W36-1000.

DEQ has determined that remedial action to address environmental contamination at Dawson Tract #1 Lift Station is complete, and no further action is required. This determination is a result of our evaluation and judgment based on the DEQ regulations and the facts as we now understand them including the following:

- The site has been used as a sewage lift station. The double-walled 600-gallon fiberglass UST supplied diesel to an emergency generator. The tank was removed on October 7, 2022.
- The cause of the contamination is attributed to leaks from the diesel tank and/or associated piping.
- Total xylenes were detected in a sample of the water in the excavation, at a concentration of 2.85 micrograms per liter. The concentration of total xylenes detected is below all risk-based contaminant levels for all pathways. Petroleum hydrocarbons were not detected in soil samples obtained from the excavation.
- Water in the tank excavation was not removed and believed to be the result of a leaking water pipe.
- Dawson Tract #1 is located within Harris Beach State Park at an elevation of approximately 68 feet above mean seal level. Domestic water for the area is drawn from the Chetco river.

Based on the available information, conditions at Dawson Tract #1 Lift Station are currently protective of public health and the environment in accordance with Oregon Administrative Rules 340-122-0205 through 340-122-0360. The site requires no further action unless new or previously undisclosed information becomes available, or there are changes in site development or land and water uses, or more contamination is discovered. DEQ will update the Leaking Underground Storage Tank (LUST) database to reflect this decision.

This letter only applies to the release(s) discussed above. If any contaminated media is encountered in the future, it must be handled and disposed of in accordance with local, state, and federal regulations.




