# TRAFFIC SAFETY COMMISSION 7:00 p.m., Monday, December 8, 2003

### 1. CALL MEETING TO ORDER:

Chairman Dick Meyer called the meeting to order at 7:00 P.M.

## 2. PUBLIC HEARING - Deliberations Continued:

A) Continued deliberations on request to sign Aaron Way as "No Parking, Fire Lane"

(New testimony will not be taken)

Chairman Dick Meyer re-opened deliberations on the matter of considering a request to sign Aaron Way as "No Parking, Fire Lane."

The Chairman introduced to the Traffic Safety Commission with a letter dated December 8, 2003, from City Attorney Terry Mahr, confirming Commission's jurisdiction to hold a public hearing and to make a decision on this matter. Further, he confirmed that the Traffic Safety Commission should not consider liability for property values when making its decision.

Mike Simpson, stating that this issue should have been completed in 1999, indicated that whatever decision was made would not satisfy all parties involved. The fact that it was missed is the matter under consideration and it does create a danger. He discussed with the Fire Department the space requirements for fire/rescue apparatus and feels that the current situation with parking on both sides creates an impossible situation, creating a safety issue for the City. Because this situation exists, he stated that it does not matter how the situation came about. Rather, it is necessary for safety of the residents that it be rectified.

**Motion:** Mike Simpson/Vergets to install three "No Parking, Fire Lane" signs on the north side of Aaron Way per construction plans dated 08/04/99. The motion passed unanimously.

Traffic Safety Commission members and the audience were advised that a fourteen day appeal period would be in effect and that public notice of the appeal period would be mailed.

Becky Simpson expressed concern over City workers using a leaf blower, blowing dead leaves into the roadway in front of City Hall. Dan Danicic will address this issue with public works staff.

Ron Sult expressed appreciation for efforts of Motor Officer Tom Perritt on red light enforcement.

Suggestion for Traffic Safety members send written letter to A-dec regarding traffic issues on Vittoria Way. No consensus. Feeling that new traffic study will reflect increased traffic counts and speeds.
