- A) Police As reported by Newell.
- Discussions are continuing on possible consolidation of the 9-1-1 Communications Center
- Newberg Police Department has been awarded Certification of Accreditation.
 - B) Engineering As reported by Danicic
- Permit has been issued for entrance/exit upgrade to Sprinbrook Plaza
- Aaron Way issue has been appealed to the Newberg City Council. To be determined is whether or not to accept additional testimony. Issue has tentatively been scheduled for March 15th.
- Recent meeting to discuss the Transportation System Plan, with a number of ideas presented for consideration. Will be completing the Transportation System Plan is in draft form, which will then be submitted to the Planning Commission for consideration. After evaluation by the Planning Commission, the plan will be submitted to the City Council.
- Concern about the driveway entrance to Friendsview Manor expressed at the last meeting. Have been in contact with the contractor and asked for better
