

RESOLUTION NO. 2601

A RESOLUTION TO UNIFY THE NAME OF THE NORTH-SOUTH ROAD KANE/257TH/GRAHAM TO 257TH AVENUE.

THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

1. The current naming convention of the street between SE Stark Street and the east-west segment of NW Graham Road includes an inconsistent set of street names which do not conform with the City's street designation code.
2. The street segment between SE Stark Street and W. Columbia River Highway is currently designated as SW 257th Drive. The street segment between W. Columbia River Highway and NW North Frontage Road is currently designated as NW Graham Road.
3. The City Council previously changed the designation of the street segment north of I-84 between NW North Frontage Road and NW Graham Road to NW 257th Drive. The east-west segment of NW Graham Road was not changed.
4. The City desires to change the street designations for each of these segments to reflect 257th Avenue in consensus with Multnomah County and ODOT.
5. The City has been working with its partner at Multnomah County Transportation, which has operational and maintenance responsibilities for the segment of SW 257th Drive from SE Stark Street to NW Frontage Road, to implement this change.
6. The City has also been working with its partner at Oregon Department of Transportation, which has operational and maintenance responsibilities for the segment of NW Graham Road within the Interstate 84 interchange, to implement this change.
7. The proposed renaming of the street between SE Stark Street and the east-west portion of NW Graham Road will result in a continuous street segment with the same street designation making navigation easier for Troutdale citizens, businesses, visitors, and safety providers as well as providing order and consistency in addressing.
8. The proposed street renaming will have minimal impact on surrounding land uses or existing addresses as property owners use them.
9. The City Council has carefully considered testimony at public meetings and has determined that it is in the best interest of the City's residents to rename the street

segment between SE Stark Street and the east-west segment of NW Graham Road to 257th Avenue.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE:

Section 1. The City of Troutdale hereby renames the street (the north-south roadway commonly called 257th Dr. or Ave.) segment from SE Stark Street northward to the east-west segment of NW Graham Road (immediately past the driveway to the City's Water Pollution Control Facility) to 257th Avenue.

Section 2. That the City Manager Ray Young, Community Development Director David Berniker, and Finance Director Erich Mueller, (each a "City Official") are designated to act individually and/or jointly, on behalf of and in the best interest of the City and without further action by the City Council, and are hereby, authorized, empowered, and directed to work with Multnomah County Transportation and Oregon Department of Transportation, to the extent needed, including execution of such necessary documents on behalf of the City, to implement the intent of this Resolution.

Section 3. Upon approval of companion action taken by Multnomah County Transportation and Oregon Department of Transportation, if such action is deemed necessary by those agencies, City staff is directed to update property addresses along the affected street segments to reflect the new street name as well as street prefixes and street designation in accordance with Chapter 15.30 of the Troutdale Municipal Code.

Section 4. That the Finance Director is authorized and directed to disburse funds, subject to annual appropriations, as necessary to fulfill the intent of this resolution and the agreements.

Section 5. This Resolution shall take effect immediately upon adoption.

RESOLUTION NO. 2024-021

To Unify the Name of the North-South Road Kane/257th/Graham to 257th Avenue in the City of Troutdale, Oregon.

The Multnomah County Board of Commissioners Finds:

- a. Multnomah County (“County”) received a request from the City of Troutdale (“City”), located within Multnomah County, to change the name of County Road No’s. 6001 and 4931 that run through the City of Troutdale.
- b. The City has been working with the County, which has operational and maintenance responsibilities for the segment of SW 257th Drive from SE Stark Street to NW Frontage Road, on changing the name of County Road No’s. 6001 and 4931.
- c. The current naming convention of County Road No’s. 6001 and 4931 between SE Stark Street and the east west segment of NW Graham Road includes an inconsistent set of street names which do not conform with the City’s street designation code. The street segment between SE Stark Street and W. Columbia River Highway is currently designated as SW 257th Drive. The street segment between W. Columbia River Highway and NW North Frontage Road is currently designated as NW Graham Road.
- d. The City desires and has requested that County Road No’s. 6001 and 4931 have a consistent name for the road as it runs through the City of Troutdale.
- e. The City, in accordance with ORS 227.120, provided public hearings and heard testimony regarding the proposed road name change and concluded that it was in the public interest to change the name of County Road No’s. 6001 and 4931 to 257th Avenue, unanimously adopting City of Troutdale Resolution No. 2601 (see attached Exhibit A).
- f. The City hereby asks for County acknowledgement and acceptance of City of Troutdale Resolution No. 2601.
- g. The City hereby asks that a certified copy of City of Troutdale Resolution No. 2601 be filed for record with the county clerk, county assessor, and county surveyor in accordance with ORS 227.120. The county surveyor shall enter the new names of such streets and roads in red ink on the county surveyor’s copy of any filed plat and tracing thereof which may be affected, together with appropriate notations concerning the same.

The Multnomah County Board of Commissioners Resolves:

1. To support, acknowledge and accept the City of Troutdale's desire to rename County Road No's. 6001 and 4931 throughout the City of Troutdale to 257th Avenue in accordance with City of Troutdale Resolution No. 2601.
2. To authorize the county surveyor to enter the new names of such streets and roads in red ink on the county surveyor's copy of any filed plat and tracing thereof which may be affected, together with appropriate notations concerning the same.
