ORDINANCE NO. 274.

An ordinance authorizing and empowering the Mayor and Recorder to enter into and sign a contract on behalf of the City of Newberg with Welton, Kibbe and Cochran for the construction of a pumping plant and extension of the water system, and for the construction of and extension to the sewer system, for the City of Newberg, for the sum of \$17630.36 and to declare an emergency.

The people of the City of Newberg do ordain as follows:

Section 1. That the Mayor and Recorder of the City of Newberg be and they are hereby authorized, empowered and directed to enter into, make and sign a contract for and in behalf and in the name of the City of Newberg with Welton, Kibbe and Cochran, for the construction of a pumping plant and extension of the water system complete, for the City of Newberg, to be done in strict accordance with the plans and specifications for said pumping plant and extension of water system accepted by the Council and on file with the Recorder of the said City of Newberg, subject only to such changes as shall be deemed advisable by said Council or its engineer, and also to construct for said City an extension to its sewer system to be constructed in strict accordance with the plans and specifications for said extension to said sewer system heretofore adopted by the Council and on file with the Recorder of said City of Newberg, subject only to such changes as shall be deemed advisable by said Council or its engineer; the said pumping plant and extension to the water system to be completed within the time and in the manner provided in said plans and specifications with such changes as may be made as aforesaid, and the said Welton, Kibbe and Cochran to give a bond to be approved as provided in said plans and specifications and to perform all things and acts in said plans and specifications required, the said extension to the sewer system to be completed within the time and manner provided in said plans and specifications with such changes as may be made as aforesaid, and the said Welton, Kibbe and Cochran to give a bond to be approved as provided in said plans and specifications and to perform all things and acts in said plans and specifications required. The price to be paid to the said Welton, Kibbe and Cochran for

the construction of said pumping plant and extension to water system as aforesaid to be the sum of \$15017.66 to be paid at the time and manner provided in said plans and specifications. The price to be paid to the said Welton, Kibbe and Cochran for the construction to the extension to sewer system as aforesaid is the sum of \$1612.70 to be paid at the time and manner provided in said plans and specifications. Said contract to be subject to the sale of the bonds of the said City of Newberg for said purposes and not to be binding until said bonds are sold and money realized for said purpose.

Section 2. The construction of the pumping plant and extension of the water system being necessary for additional water supply and the additional water supply and the construction of the extension to the sewer system being necessary for the immediate preservation of the health and safety of the City of Newberg and the inhabitants thereof this ordinance shall be in full force and effect from its approval by the Mayor.
