# **CALL TO ORDER**

Kavanagh called the meeting to order at 4:01 p.m.

# COMMITTEE REPORTS

Proposed cruise dock planting area/ Downtown trash can placement

Nelson, Ferrer, Kavanagh met at cruise dock to look at planter area/hillside and drove together to look at potential trash can placement.

Ferrer will plot the trashcan plan onto a map.

Committee discussed budgeting for bike racks & benches next year—FY 24/25

Rahmlow said to keep in mind adding benches, planters, racks when choosing trash can locations.

Committee discussed proposing up to 44 trash cans in a letter to Urban Renewal.

Kavanagh said the Director of Community Development asked the BTC (Beautification & Tree Committee) to draw up a plan & proposal for the planter and hillside near dock.

Nelson said in the Spring, the BTC would have a better idea of what native plants are currently on the hillside. Then use that information to determine what to add.

Ferrer asked for a work session in January. BTC understood no decisions could be made at a work session.

Ferrer said the hillside area will require maintenance, weed eating, pruning. City needs a plan with low/no maintenance but this may not be possible on that hillside.

Kavanagh said a small group of volunteers may be needed to help the city maintain.

Ferrer said BTC may help with weeding, along with tracking the City's parklet/triangles.

Mello said the existing plants need cleaning up not completely removed, then added the plan should include a plan for maintenance.

Ferrer recommended 44 trash cans to be purchase by Urban Renewal Agency and placed in locations near suggested areas.

The BTC discussed the number of trash cans and locations for a proposal to Urban Renewal.

Ferrer moved the BTC submit a proposal to the Urban Renewal Agency for the purchase of up to 50 trash cans placed in suggested locations downtown. It was seconded by Mello; the motion passed 4 to 1; Ferrer, Mello, Nelson, Kavanagh in favor; Rahmlow opposed; Drinkwine absent.

# Work session at CGCC

I'm sure one of us could give a presentation about the partnership during the garden show exhibit, and we could also cover Backyard Habitat as well if you think that is of interest to participants. Regarding native plants, I'm so glad you're connecting with Drew and Kristin. You could also reach out to Barbara Robinson and Paul Slichter, cc'd on this email. They are two of the region's preeminent botanists (though they will humbly deny this) and have a wealth of knowledge about our local flora. Paul curates a <a href="website">website</a> at <a href="http://science.halleyhosting.com/">http://science.halleyhosting.com/</a> and Barbara has been lovingly restoring a native plant community and interpretive walk at the Discovery Center for over a decade. If you haven't already, you should find ways to elevate and support their work through the garden show to promote native plants.

We'd be happy to talk about the East Cascades Oak Partnership and the value of Oregon white oak. It's so easy to take them for granted around here, but we can change that! I also thought I'd point you to a <u>webinar</u> given a year ago by author Doug Tallamy at one of our partnership meetings. Doug is really passionate about the native oaks where he lives and will inspire just about anyone who has an oak in their yard! As an aside, he's also started a nonprofit that is similar to the Backyard Habitat Program called Homegrown National Park whose mission is to plant 20 million acres (½ of America's lawns!) with native plants.

Thanks for reaching out and for your support of land conservation and native plant stewardship in the gorge. Let me know what you're thinking about presentations and good luck with your planning efforts.
