APPLICANT: Bryon Parke, doing business as **Sandman Coatings, LLC**

PROPERTY OWNER: Bryon Parke

APPLICATION NUMBER: HBP 120-24

REQUEST: To operate a home business for firearm smithing and coatings.

LOCATION: Property is located at 2120 E. 16th Street, The Dalles, Oregon, and is further described as 1N 13E 11 BA tax lot 901. Property is zoned RL – Low Density Residential.

REVIEW CRITERIA: The City of The Dalles Comprehensive Land Use Plan, The Dalles Municipal Code Title 10 Land Use and Development, Article 5.010 RL – Low Density Residential District; Article 6.020 Home Businesses.

COMMENT PROCEDURE:

1. **Written comments for or against the proposal will be accepted for 14 days from the date this notice is mailed and are due by 5:00 p.m., May 1, 2024** in the Community Development Office, City of The Dalles, 313 Court Street, The Dalles, Oregon 97058.
2. Failure to raise an issue in writing within the comment period, or failure to provide statements or evidence sufficient to afford the decision maker an opportunity to respond to the issue, precludes further appeal on that issue.

3. Copies of all review criteria and evidence relied upon by the decision maker or evidence provided by the applicant **are available for free review or may be purchased at the Community Development Office**, City of The Dalles, 313 Court Street, The Dalles, Oregon 97058.

DECISION PROCESS:

1. An application is received, decision date set, and notice mailed to property owners within 100 feet of the subject property.
2. All affected City departments and other agencies are asked to comment.
3. All timely comments and the application are weighed against the approval criteria in a staff report.
4. The provisions of the The Dalles Municipal Code, Title 10 Land Use and Development and the City of The Dalles Comprehensive Plan must be met.
5. A decision is reached by the Director based on the Findings of Fact in the staff report.
6. Parties of Record (notified property owners, affected public agencies, and other parties who make timely comment) will receive a Notice of Decision.
7. Aggrieved parties may appeal an Administrative Decision to the Planning Commission within 10 days of the date a notice of Decision is mailed, subject to the requirements for appeal procedures.

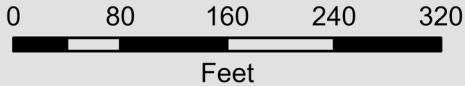
